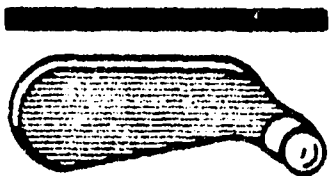
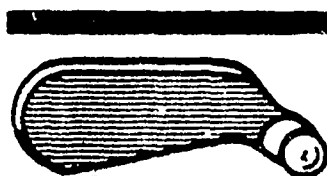



### Read Statements on Recall Inside

(Section 183 of the Charter of the City and County of San Francisco provides:

"With or upon the sample ballot mailed to each voter prior to a recall election, there shall be transmitted the reasons for demanding the recall of the officer as set forth in the recall petition, printed in not more than three hundred words, and with or upon the same ballot the printed statement of the officer in not more than three hundred words justifying his course in office.")

# Reasons for Demanding the Recall of the Mayor as Set Forth in the Recall Petition

The grounds on which the removal of Roger D. Lapham as Mayor of the City and County of San Francisco is sought:

1. Mayor Roger D. Lapham has wilfully, deliberately and flagrantly violated a mandate of the people expressed at election Nov. 6, 1946, against an increased carfare.
2. He has attempted at all times since to foist upon the people of the City and County of San Francisco and against their will said increased carfare.
3. He has brought disrespect and discredit to the city by upbraiding agencies of the United States Government engaged in enforcing the law.
4. He has caused much unnecessary expense to the city through such tactics in disregard of the public will; forced court hearing with attendant loss of time and money, thus impeding settlement of many legal matters pending in the courts.
5. His conduct has been arrogant and contemptuous of the electorate, and he has at all times toadied to the interests of special groups in utter disregard and neglect of the community as a whole. He has discriminated against the neighborhoods in favor of downtown.
6. He has lost public confidence and hurt the prestige of the city by his calloused indifference. In his public utterances and official life he has exhibited a bored and tired attitude notwithstanding the city's need of an alert, responsive official.
7. He has been negligent, incompetent and intolerant in office.
8. His failure to be "on the job" for which he was elected cost San Francisco its favorable position as potential United Nations capital.
9. He has forgotten the "business principles" upon which he was elected, and has directed city affairs in a completely dictatorial manner.

# Statement of Roger D. Lapham Justifying His Course in Office

TO THE CITIZENS OF SAN FRANCISCO:

When I asked you to elect me Mayor nearly three years ago, I pledged you to serve but one four-year term—and I want to finish that one four-year term.

I said then I was no miracle man. I promised a sound, honest, businesslike administration.

I promised to build no political machine, to become no one's political puppet nor to mortgage my freedom of action to any man. I promised to do my best to serve San Francisco first, and chiseling promoters not at all. The phrase I used was "Freedom from humbug."

I have kept my pledges, but no man in public office who calls his shots as he sees them can hope to escape the wails of disgruntled office seekers. The accusations against me are all "bum beefs." Who is really behind this recall? Who wants to take over?

San Francisco has the reputation of being a city of fair play. That people differ with my actions and decisions is just as it should be—that is democracy, but I do not believe you citizens will tolerate a political lynching because of honest differences of opinion.

Many projects launched during my administration are at the half-way stage. With your help, I would like to complete them. I am no quitter.

I repeat, I want to serve out my remaining year and a half, and I pledge you I will continue to call my shots as I see them.

# An Open Letter to San Francisco Voters

## READ THIS EXPOSE OF THE REAL MOTIVES BEHIND THE ATTEMPT TO RECALL MAYOR LAPHAM

FELLOW SAN FRANCISCANS:

Not since the days when San Francisco was a boss-ridden city have the voters been called upon to repudiate a political power-grab as bold as the current attempt to take over the City Hall at the July 16 special election!

An overwhelming "NO" vote will provide the only language understandable to the political jugglers seeking, as their first objective, the ouster of Mayor Roger D. Lapham.

### THE ISSUE

Mayor Lapham is the target, BUT HE IS NOT THE ISSUE!

**The issue** is whether the City Hall and the city government are to be turned over to an unholy alliance fronted by a puppet mayor picked out of a grab-bag.

**The issue** is whether you, as citizens, will retain your Democratic right to choose your own chief city executive, or surrender that power into other hands.

**The issue** is whether you will permit the instrument of recall to be misused and diverted from its real intent—which provides a method of removing a city official guilty of graft, corruption, malfeasance or misfeasance—into an instrument for the political execution of a public servant whose honesty and integrity are unchallenged.

### WHO IS THE UNDER-COVER CANDIDATE?

To recall Mayor Lapham on the flimsy charges specified by the recallers would be tantamount to putting a bludgeon into the hands of shady politicians and inviting them to use it to browbeat any elected city official who refuses to bend the knee to their demands.

Make no mistake about this. There is more—much more—behind this recall drive than appears on the surface.

It is not a mere crack-pot adventure by publicity seekers.

Because, as devious politicians, they figured their chances would be better at a special election in a summer month when thousands of voters will be away on vacation. Suppose it does cost \$68,000 of the people's tax money? The obvious slogan of the recallers is "the public be damned!"

The recallers knew exactly what they were doing **AND THEY HAVE A CHANCE TO SUCCEED.** Absent voters, and apathy are their best allies.

## **YOUR CITY IS IN JEOPARDY!**

In the opinion of the recallers, many voters may be expected to think that this is just a crack-pot scheme, a silly-season exploit of amateur politicians and publicity seekers. The recallers feel that many won't bother to vote at all—and a minority, however small, will turn the trick for the recall interests.

**THAT'S EXACTLY WHAT WILL HAPPEN ON JULY 16 UNLESS THE PUBLIC AWAKENS TO THE SERIOUSNESS OF THIS POLITICAL USURPATION OF THE MAYOR'S OFFICE.**

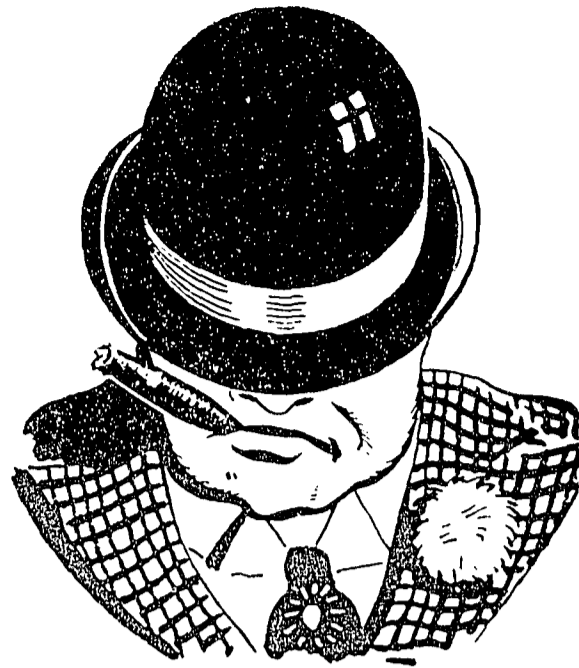

# What Has Mayor Lapham Done For You?

## Apply These Tests

### And You Cannot Fail to Vote YES on July 16

1. *The Transportation Test:* You are now being charged 10c a single ride, or 3 rides for a quarter by Lapham's Utility Commission. There is no present prospect of better service. Mayor Lapham made a warning statement that even this recent raise may not be enough. If you object, yours is a "Bum Beef."
2. *The Tax Test:* Mayor Lapham and his adherents have so bungled the budget that the realty groups, and others, contemplate suing the City to prevent the threatened collection of \$1.00 more per hundred in taxes. If you protest, you have a "Bum Beef."
3. *The Interest Test:* Lapham and his friends have so arranged it that you are paying 4% interest on the Market Street Railway Debt, when money is available everywhere at  $\frac{1}{2}$  of 1% interest. Millions of dollars in City-money are out at only  $\frac{1}{2}$  of 1%. If you disagree with them, it's a "Bum Beef."
4. *The Airport-Development Test:* Instead of prompt action for the development of the \$20,000,000 Municipal Airport, Lapham even vetoed measures designed to get things started there. It took action from the Board of Supervisors, in the form of overriding the Mayor's inaction, to expedite the program. If you dislike the Mayor's "not-doing-things," it's a "Bum Beef."
5. *The Water-Rates Test:* The City Water System made a profit of \$2,000,000 last year, but your water rates were raised to make you pay the highest water-rates in the Country. If you don't like that, your objection is a "Bum Beef."
6. *The Aid-to-Veterans Test:* Lapham insisted on the closing of our fine Hospitality House, and would prefer to let our heroic servicemen find for themselves diversion at poolrooms, dives and cocktail bars. If you think that unreasonable, you make a "Bum Beef."
7. *The Harbor and Recreational Test:* Mayor Lapham ignores the public's need for the development of our harbor, the finest in the world. Small-boat operators cannot find moorings here to visit the City, and spend welcome tourist-money. The City's Aquatic Park remains undeveloped, and our children have no "Swimmin' Hole" for recreation. If you disagree, your opinion is a "Bum Beef."

*Who Is Behind the Recall?* 24,459 registered voters, including the Mayor, signed the petitions for his recall.

*Who Started the Recall?* Roger D. Lapham himself. He has so aroused tens of thousands of our citizens by his wilful actions that hundreds of citizens voted for a cleanup of the Mayor's Office in the impartial poll conducted by the San Francisco Progress. The results were 20 to 1 demanding his recall.

*The Recall has been endorsed* by the Veterans' Non-Partisan League, by the Warehousemen's Union, Local 860, A.F.L., and by UNION LABOR, as represented by The American Federation, headed by these outstanding leaders: Thomas P. "Ted" White, general chairman, and Victor S. Swanson, executive chairman.

These organizations join the Recall Lapham Committee of 1100 in presenting this bill of particulars against Lapham for your earnest consideration.

*Who Will Benefit From the Recall?* The Right of Recall is the Constitutional Guarantee to the People whereby they alone will benefit. This is the only way the people can say:

STOP FOISTING EXPENSIVE TRANSPORTATION ON US. A 10c

FARE IS UNREASONABLE — THE 7c FARE IS ENOUGH.  
STOP BOOSTING OUR TAXES. OUR MONEY BUYS LITTLE  
ENOUGH.

STOP FORCING US TO PAY THE HIGHEST WATER RATES  
IN THE COUNTRY.

*Who Will Be Elected Mayor?* The Board of Supervisors has the duty to fill the vacancy of the Mayor's office by our Charter, and this provision was passed by the people upon its submission to the electorate by the Board of Freeholders, one of whom was the Mayor's estimable Mr. Francis Keesling, who now sees things "the other way."

*The Supervisors* are the elected representatives of the People, who have a high trust to perform for the citizens of San Francisco. They have acted with courage and intelligence on two other occasions. They elected Dr. Taylor to occupy the vacancy created by Mayor Schmitz's removal, and they elected Angelo J. Rossi Mayor when our famous Sunny Jim Rolph vacated the office to become Governor of California

Not then, and not now, need we fear that a crepe wreath will ever adorn the City Hall because of their election. The Board of Supervisors has precedence, experience and the wisdom to guide them in the election of a man better qualified to give you the sound, solid administration needed to replace the Lapham Dictatorial maladministration.

*Extreme Pressure*, verging on intimidation, has been brought to bear on your Supervisors by the dailies. They are using every press tactic to "SMASH the WILL OF THE PEOPLE."

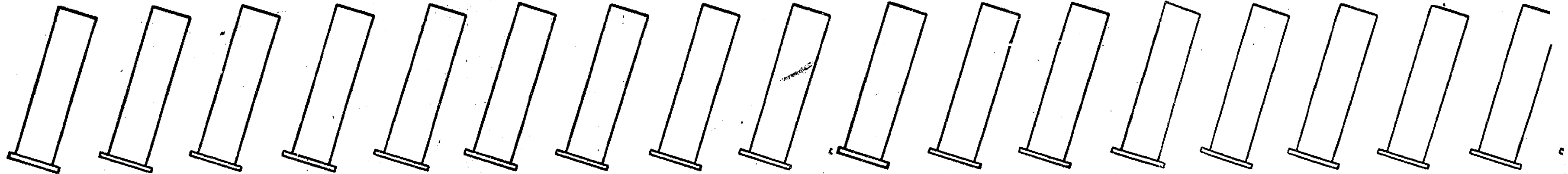

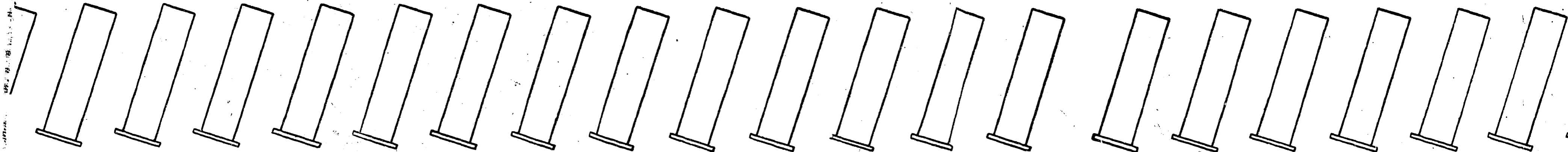

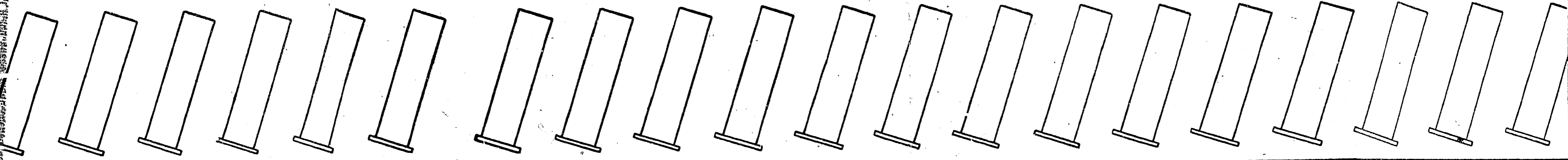
