## **CHARTER AMENDMENT No. 1**

**FIRE DEPARTMENT.** Amending Section 171 of Charter, designating Fire Department members, prescribing their contributions, conditions of retirement and pensions they will receive.

### **CHARTER AMENDMENT NO. 1**

Describing and setting forth a proposal to the qualified electors of the City and County of San Francisco to amend the Charter of said City and County by amending Section 171 thereof (future members of the Fire Department) relating to retirement of certain members of the Fire Department and prescribing contributions and conditions and amounts of pensions to be paid.

The Board of Supervisors of the City and County of San Francisco hereby submits to the qualified electors of the City and County of San Francisco, at an election to be held therein on November 2, 1943, a proposal to amend the Charter of said City and County by amending Section 171 thereof, to read as follows:

#### **FUTURE MEMBERS OF THE FIRE DEPARTMENT**

Section 171. Members of the Fire Department, who shall be members of the Retirement System under Section 171 of the Charter, on the effective date hereof, hereby defined as the first day of the month next following the ratification of this amendment by the Legislature, and other persons who shall be employed in said Department and shall be members of the System under Section 165 of the Charter on said effective date, but who, under this section, become members of the Fire Department as defined herein, and persons who shall become members of said Department after said effective date, shall be members of the Retirement System on and after said date, subject to the following provisions of this Section 171, in addition to the provisions contained in Section 158 to 161, both inclusive, of this Charter. Members of said Department who shall be members of the Retirement System under Section 169 of the Charter on said effective date, shall have the option to be exercised in writing on a form furnished by the Retirement System, of being members of the System under this Section 171 instead of Section 169, the election under said option to be effective on the day said completed form is received at the office of said system. On and after said date, the person who affirmatively exercises said option, shall be a member of the System under Section 171 and shall not be subject to any of the provisions of Section 169. Members of said Department who are members of the Retirement System under said Section 169, and who do not affirmatively exercise said option, shall not be subject to any of the provisions of Section 171.

(a) The following words and phrases as used in this section, unless a different meaning is plainly required by the context, shall have the following meanings:

"Retirement allowance," "Allowance" shall mean equal monthly payments, beginning to accrue upon the date of retirement, or upon the day following the date of death, and continuing for life unless a different term of payment is definitely provided by the context, equal to fifty per cent of the final compensation of the person to whom, or on account of whose death, said payments are made. The amount of any retirement allowance, or allowance, shall not be changed after determination under this

section, regardless of changes in salaries attached to positions or ranks in the Fire Department.

"Compensation," as distinguished from benefits under the Labor Code of the State of California, shall mean the remuneration payable in cash, by the City and County without deduction except for absence from duty, for time during which the individual receiving such remuneration is a member of the Fire Department.

"Compensation earnable" shall mean the compensation which would have been earned had the member received, compensation without interruption throughout the period under consideration and at the rates of remuneration attached to the ranks of positions held by him during such period, it being assumed that during any absence he was in the rank or position held by him at the beginning of the absence, and that prior to becoming a member of the Fire Department he was in the rank or position first held by him in such Department.

"Final compensation" shall mean the average monthly compensation earnable by a member during the three years immediately preceding his retirement, or death before retirement.

For the purposes of the Retirement System and of this section, any officer or employee included in the uniformed force of the Fire Department whose employment was or shall be subject to a Charter maximum age at the time of employment of not over thirty-five years, shall be considered to be a member of the Fire Department. Other persons employed on and after the effective date hereof, in the Fire Department to perform the duties now performed under the titles of marine engineer, pilot and marine stoker on the fire boats, or of hydrantman-gateman, and foreman hydrantman-gateman, shall also be considered to be members of the Fire Department from the effective date of their employment in said department, for purpose of the Retirement System and of this section. Any fire service performed by such a member of the Fire Department outside the limits of the City and County and under orders of a superior officer of any such member, shall be considered as City and County service, and any disability or death incurred therein shall be covered under the provisions of the Retirement System.

"Retirement System" or "System" shall mean San Francisco City and County Employees' Retirement System as created in Section 158 of the Charter.

"Retirement Board" shall mean "Retirement Board" as created in Section 159 of the Charter.

"Charter" shall mean the Charter of the City and County of San Francisco.

Words used in the masculine gender shall include the feminine and neuter genders, and singular numbers shall include the plural, and the plural the singular.

"Interest" shall mean interest at the rate adopted by the Retirement Board.

(b) Any member of the Fire Department who shall have completed at least twenty-five years of continuous service computed as provided in subsection (h) hereof, may retire for service at his option. A member retired under this subsection (b) shall receive a retirement allowance equal to fifty per cent of the final compensation of said member, as defined in subsection (a) hereof.

(c) Any member of the Fire Department, who shall become incapacitated for performance of his duty by reason of any bodily injury received in, or illness caused by the performance of his duty, shall be retired, and shall receive a retirement allowance equal to fifty per cent of the final compensation of said member, as defined in subsection (a) hereof. Any member of the Fire Department who shall become incapacitated for performance of his duty, by reason of a cause not included under the provisions of the immediately preceding sentence, and who shall have completed at least ten years of continuous service computed as provided in subsection (h) hereof.

shall be retired upon an allowance of one and one-quarter per cent of the final compensation of said member, as defined in subsection (a) hereof, for each year of service, provided that said allowance shall not be less than twenty-five per cent of said final compensation. The question of retiring a member under this subsection may be brought before the Retirement Board on said Board's own motion, by recommendation of the Fire Commission or by said member or his guardian. If his disability shall cease, his retirement allowance shall cease, and he shall be restored to the service in the rank he occupied at the time of his retirement.

(d) If a member of the Fire Department shall die (1) as the result of an injury received in, or illness caused by the performance of his duty, or (2) while eligible to retire under subsection (b) of this section, or (3) after retirement for service under subsection (b) hereof or under subsection (c) hereof, because of any bodily injury received in, or illness caused by the performance of his duty, a monthly allowance shall be paid to his surviving wife, equal to fifty per cent of the final compensation of said member, the allowance to continue throughout her life or until her remarriage; or if there be no surviving wife entitled to an allowance hereunder, or if she die or remarry before every child of such deceased member shall have attained the age of eighteen years, then said allowance shall be paid, to his child or children under said age collectively to continue until every such child shall die or attain said age, provided that no child shall receive any allowance after marrying or attaining the age of eighteen years. Should said member leave no surviving wife and no children under the age of eighteen years, but leave a partner or parent dependent solely upon him for support, the parents so dependent shall collectively receive said monthly allowance during such dependency. No allowance, however, shall be paid under this subsection to a surviving wife following the death of a member:

(1) after being retired under subsection (b) of this section, regardless of the cause of death, unless said surviving wife of the deceased member was married to said member at least one year prior to retirement; or

(2) after being retired under subsection (c) of this section unless retirement be due to injury received in, or illness caused by the performance of duty and unless said surviving wife was married to said member at least one year prior to death; or

(3) if said death be due to causes other than injury received in, or illness caused by the performance of his duty, and if said death shall occur before retirement but while eligible to retire under subsection (b) of this section, unless said surviving wife was married to said member at least one year prior to death.

(e) Any allowance payable because of the death or retirement of any member of said Department shall be reduced in the manner fixed by the Board of Supervisors, by the amount of any benefits, other than medical benefits, payable to or on account of such person, under the Labor Code of the State of California.

(f) If a member of the Fire Department shall die, before retirement, from causes other than an injury received in, or illness caused by the performance of duty, or regardless of cause, if no allowance shall be payable under subsection (d) preceding, a death benefit shall be paid to his estate or designated beneficiary, the amount of which and the conditions for the payment of which shall be determined in the manner prescribed by the Board of Supervisors for the death benefit of other members of the Retirement System.

(g) Should any member of the Department cease to be employed as such a member, through any cause other than death or retirement or transfer to another office or department, then all of his contributions, with interest credited thereon, shall be refunded to him forthwith. If he shall again become a member of the Department, he



shall deposit in the Retirement Fund, the amount refunded to him. If a member of the Fire Department shall become a member of the Police Department, his contributions, with credited interest, shall remain credited to his account, and for purposes of the Retirement System, he shall receive credit for the time served as a member of the Fire Department in the same manner as if it had been served in the Police Department. If a member of the Retirement System shall become a member of the Fire Department from a status other than that of a member of the Police Department, his contributions, with credited interest shall be refunded to him and he shall not receive credit for any service other than that rendered as a member of the Fire Department. Should a member of the Fire Department become an employee of any other office or department other than the Police Department, a portion of his contributions with credited interest equal to the contributions which would have accumulated to his credit if he had been employed in said office or department at the rate of compensation received by him in the Fire Department, shall remain credited to his account, and he shall receive credit for service to the extent of said accumulated contributions, and the balance of his contributions with credited interest shall be refunded to him forthwith.

(h) The following time shall be included in the computation of the service to be credited to a member of the Department for the purpose of determining whether such member qualifies for retirement:

(1) Time during and for which said member is entitled to receive compensation because of services as a member of the Department.

(2) Time during and for which said member, if he shall be a member of the Retirement System under Section 171 of the Charter on the effective date hereof, was entitled to receive compensation because of services as an officer or employee of any other office or department, prior to said effective date.

(3) Time during which said member, while on leave of absence from said department without salary, has served or shall serve in the military, naval or air forces of the United States of America during any war in which the United States was or shall be engaged.

(i) All payments provided under this section shall be made from funds derived from the following sources, plus interest earned on said funds:

(1) There shall be deducted from each salary payment made to each member of the Fire Department, who is a member of the Retirement System under this section, a sum equal to five per cent of such salary payment, notwithstanding the provisions of Section 160 of the Charter. The sum so deducted shall be paid forthwith to the Retirement System. Said contribution shall be credited to the individual account of the member from whose salary it was deducted, and the total of said contributions, together with interest credited thereon in the same manner as is prescribed by the Board of Supervisors for crediting interest to contributions of other members of the Retirement System, shall be applied to provide part of the retirement allowance granted to, or allowance granted on account of said member, under this section, or shall be paid to said member or his estate or beneficiary as provided in subsections (f) and (g) of this section.

(2) The total contributions deducted from salary earned by persons who become members under this section, prior to the effective date hereof, together with interest thereon, and standing to the credit of such member on the records of the Retirement System on said date, shall continue to be credited to the individual accounts of said members and shall be subject to the last sentence of paragraph (1) next preceding, in exactly the same manner as the contributions provided for in said paragraph.

(3) The total contributions, with interest thereon, made by the City and County

and standing to its credit, in the accounts of the Retirement System, on account of persons who become members under this section, shall be applied to provide the benefits under this section.

(4) The City and County shall contribute to the Retirement System such amounts as may be necessary, when added to the contributions referred to in the preceding paragraphs of this subsection (i), to provide the benefits payable under this section. Such contributions of the City and County to provide the portion of the benefits hereunder which shall be based on service rendered prior to the effective date hereof, shall not be less during any fiscal year than the amount of such benefits paid during said year. Such contributions of the City and County to provide the portion of the benefits hereunder which shall be based on service rendered on and after the effective date hereof, shall be made in annual installments to be paid in any year shall be determined by the application of a percentage to the total salaries payable during said year, to persons who are members under this section, said percentage to be the ratio of the value at the effective date hereof, or at the later date of a periodical actuarial valuation and investigation into the experience under the System as provided by the Board of Supervisors, of salaries thereafter payable to said members then in the Fire Department to the value at said effective or said later date of the benefits thereafter to be paid under this section, from contributions of the City and County, less the amount of such contribution, plus accumulated interest thereon, then held by said System to provide said benefits on account of service rendered after the effective date hereof. Said values shall be determined by the Actuary, who shall take into account the interest which shall be earned on said contributions, the compensation experience of members, and the probabilities of separation by all causes, of members from service before retirement and of death after retirement. Said percentage shall be changed only on the basis of said periodical actuarial valuation and investigation into the experience under the System.

To promote the stability of the Retirement System through a joint participation in the results of variations in the experience under mortality, investment and other contingencies, the contributions of both members and the City held by the System to provide the benefits under this section, shall be a part of the fund in which all other assets of said System are included, but the accounts of said System shall be kept in such manner as to permit the segregation of assets equal to the total contributions with interest credited thereon, held by said System to provide the benefits under this section, and to permit the determination that, except for said joint participation, all payments provided under this section shall be made from the contributions provided for herein.

(j) Upon the completion of the years of service set forth in subsection (b) of this section as requisite to retirement, a member shall be entitled to retire at any time thereafter in accordance with the provisions of said subsection (b), and no amendment to this charter or repeal of this section, or any other event or occurrence of whatever nature shall deprive said member of said right.

(k) No person retired for service or disability and entitled to receive a retirement allowance under the Retirement System shall serve in any elective or appointive position in the City and County service, including memberships on boards and commissions, nor shall such person receive any payment for service rendered to the City and County after retirement, provided that service as an election officer or juror shall not be affected by this section.

Should any retired person, except persons retired because of disability incurred in the performance of duty, engage in a gainful occupation prior to attaining the age of sixty-two, the Retirement Board shall reduce that part of his monthly pension or retire-

ment allowance which is provided by contributions of the City and County, to an amount which, when added to the amount earned monthly by him in such occupation, shall not exceed the compensation on the basis of which his pension or retirement allowance was determined, provided, that the provisions of this paragraph shall not apply, during any war in which the United States is or may be engaged, to persons retired under this section.

(1) Any section, or any part of any section in this Charter, insofar as it should conflict with this Section 171, or with any part thereof, in the application of said Section 171 to persons who are members of the Retirement System under Section 171, shall be superseded by the contents of said Section 171. In the event that any clause, section or phrase of this charter amendment shall be adjudged unconstitutional, the remainder thereof shall remain in full force and effect.

## CHARTER AMENDMENT No. 2

**SEWER CONSTRUCTION AND RECONSTRUCTION.**  
Amending Section 78 of Charter to include not less than 10c in tax levy for sewers, from 1944 to 1954, inclusive.

## CHARTER AMENDMENT NO. 2

Describing and setting forth a proposal to the qualified electors of the City and County of San Francisco to amend the Charter of said City and County by amending Section 78 thereof, relating to the tax levy by including therein the sum of not less than ten cents each year for the years 1944 to 1954, inclusive, for the construction, reconstruction, repair, maintenance or improvement of sewers or the sewer system.

The Board of Supervisors of the City and County of San Francisco hereby submits to the qualified electors of said City and County, at an election to be held therein on November 2, 1943, a proposal to amend the Charter of said City and County by amending Section 78, thereof, to read as follows:

Section 78. On or before the 15th day of September of each year, the Board of Supervisors by ordinance shall levy a tax, the estimated proceeds of which, together with the total amount of receipts and revenues estimated to be received from all sources, will be sufficient to meet all appropriations made by the annual appropriation ordinance.

Revenue to meet current annual interest and redemption or sinking fund for outstanding bonds shall always be provided out of the tax levy; provided, however, that to the extent to which funds are appropriated by the public utilities commission, and available for annual interest and redemption or sinking fund on bonds issued for ac-

quisition, construction or extension of any utility, no tax shall be levied therefor.

The tax levy shall not exceed the rate of one dollar and sixty-five cents (\$1.65) on each one hundred dollars (\$100.00) valuation of the property assessed in and subject to taxation by the city and county exclusive of the following items: (1) State taxes, and taxes for the interest and sinking fund on bonded indebtedness of the city and county; (2) the cost of constructing, reconstructing, repairing, maintaining and improving (a) schools, (b) libraries, which tax shall not be less than four cents on each one hundred dollars, (c) parks and squares, which tax shall not be less than ten cents on each one hundred dollars, (d) playgrounds, which tax shall not be less than seven cents on each one hundred dollars, (e) for the art commission for purpose of maintaining a symphony orchestra one-half cent on each one hundred dollars of said assessed valuation, (f) streets, sewers and buildings, provided that each year for the period commencing 1944 and ending 1954 there shall be included in each annual tax rate, not less than ten cents on each one hundred dollars of assessed valuation for the construction, reconstruction, maintenance, improvement or repair of sewers for the sewage system; (3) the cost of (a) elections, (b) civil service, which tax shall not be less than one-half cent on each one hundred dollars, (c) obligations imposed by State legislative or constitutional enactment and (d) obligations imposed by vote of the people of the city and county.

## CHARTER AMENDMENT No. 4

**POLICE DEPARTMENT. Amending Section 35.5 of Charter fixing salary of Captain of Traffic at \$5300 a year.**

### CHARTER AMENDMENT NO. 4

Describing and setting forth a proposal to the qualified electors of the City and County of San Francisco, State of California, to amend section 35.5 of the Charter of the City and County of San Francisco, relating to compensation for members of the Police Department by increasing the salary of the Captain of Traffic.

The Board of Supervisors of the City and County of San Francisco hereby submits to the qualified electors of said City and County at the General Municipal Election to be held on the second day of November, 1943, a proposal to amend the Charter of said City and County by amending Section 35.5 thereof, to read as follows:

Section 35.5. The police force of the city and county shall not exceed one police officer for each five hundred inhabitants thereof. The annual compensations for the several ranks in the department shall be as follows: Chief of Police, \$7,500; Deputy Chief of Police, \$5,700; Captain of Inspectors and Captain of Traffic, each, \$5,300; Department Secretary, \$5,100; Director, Bureau of Criminal Information, Director, Bureau of Personnel and Supervising Captain of Districts, each, \$4,300; Captains and Criminologist, \$3,900; Lieutenants and Director, Bureau of Special Services, each, \$3,300; Inspectors, \$3,060; Sergeants, \$2,940; Police Surgeon, \$2,700; Photographer, \$3,000; Police Officers, Police Patrol Drivers, and Women Protective Officers, for first year of service, \$2,400; for second year of service, \$2,400; for third year of service, \$2,400; for fourth year of service, \$2,520; for fifth year of service, \$2,580; for sixth year of service, \$2,640; for seventh year of service and thereafter, \$2,700.

The minimum annual compensation for police officers, women protective officers, and police patrol drivers, who have been or shall be appointed from eligible lists established prior to January 11, 1943, shall be \$2,520, and further adjustments shall be in accordance with the preceding paragraph.

In determining years of service necessary for a police officer, woman protective officer and police patrol driver to receive the annual compensation sum of \$2,580, \$2,640, and \$2,700, respectively, as provided for herein, service rendered prior to the effective date of this amendment shall be given full credit and allowed. All service under this section shall be computed on the calendar year basis.

The absence of any police officer, woman protective officer, or police patrol driver on military leave of absence, as defined by section 153 of this charter, shall be reckoned a part of his service under the city and county for the purpose of computing years of service in gaining added compensation as provided for herein.

Any member assigned to two-wheel motorcycle traffic duty shall receive \$15 per month in addition to the compensation to which he would otherwise be entitled.

## CHARTER AMENDMENT No. 5

**CONTINUOUS SERVICE.** Amending Section 161 of Charter requiring City to make contributions to Retirement System for city employees engaged in armed services.

### CHARTER AMENDMENT NO. 5

Describing and setting forth a proposal to the qualified electors of the City and County of San Francisco to amend the Charter of said City and County by amending Section 161 thereof, relating to Continuous Service of Employees.

The Board of Supervisors of the City and County of San Francisco hereby submits to the qualified electors of the City and County of San Francisco, at an election to be held therein on November 2, 1943, a proposal to amend the Charter of said City and County by amending Section 161 thereof, to read as follows:

#### CONTINUOUS SERVICE

Section 161. Continuous service shall be defined by the board of supervisors, but the absence of any officer or employee of the city and county from service caused by reason of the service of such officer or employee in the military or naval forces of the United States in any war in which the United States has engaged, shall not be deemed to be absence from service for the purposes of the retirement system and such officer or employee shall receive credit under the retirement system, for the period of such absence, in the same manner as if he had not been absent.

Any contributing member of the retirement system who is absent after September 14, 1940, from the service of the city and county, by reason of service in the armed forces of the United States, or the state of California or service on ships operated by or for the United States government, and for such time thereafter as may be provided by rule of the civil service commission, but not to exceed two years after the proclamation of peace, except in case of disability incurred in the line of duty with said armed forces or on said ships when such disability extends beyond such period, or any service connected with the war effort for which leaves of absence shall be authorized pursuant to section 153 of the charter, or any such member who is absent after September 14, 1940, from the service of the city and county, by reason of an order of the government of the United States or the State of California, or by lawful order of any of the departments or officers of said governments, may elect to contribute to said retirement system while serving in said forces or on said ships, and at times and in a manner to be fixed by the retirement board, amounts equal to the contributions which he would have made from the beginning of said absence, or from the date of said election, had he remained on duty in the position he occupied and at the compensation being earned by him immediately prior to the beginning of said absence. The city and county shall contribute to the retirement system on account of any member who exercises affirmatively the election provided herein, and on account of any non-contributing member who is absent by reason of service stated in this paragraph, in the same manner and amounts as if said member were not absent in said service. If the member's base pay in said service shall be less than one hundred dollars per month, city and county, in lieu of said member, shall contribute also said amount which the member otherwise would

have been required to contribute under said election, and said contribution shall be administered as if made by said member.

It is the purpose of the paragraph next preceding, to place a member who is absent from the service of the city and county by reason of service as set forth in paragraph next preceding, and who contributes or for or on account of whom contributions are made as herein provided, in the same status under the retirement system, as that which he would have occupied had he remained on duty in the position he occupied immediately prior to the beginning of said absence and charter and ordinance provisions governing the retirement system, shall apply to said member with like effect as if he were not absent. If, however, a member who exercises affirmatively the election provided herein, shall default in any of the contributions due to the retirement system under said election, and if said contributions are not made for him, then he shall be considered absent from service during the period covered by said defaulted contributions, the same as if he had not exercised affirmatively said election, and he shall not receive credit as service for the city and county, for the period covered by said defaulted contributions; but the absence during said period of default shall not break the continuity of service required of such member to entitle him to a pension or retirement allowance, as provided under the retirement system.

Any member of the retirement system who is absent from the service of the city and county by reason of service set forth in the second paragraph of this section, and who does not affirmatively exercise election herein provided, shall not receive credit as service for the city and county, for the period of such absence, but the absence shall not break the continuity of service required of such member to entitle him to a pension or retirement allowance as provided under the retirement system.

## **CHARTER AMENDMENT No. 6**

**RECREATION DEPARTMENT.** Amending Section 42 of Charter fixing four years as the term of office of each commissioner of Recreation Department.

## **CHARTER AMENDMENT NO. 6**

Describing and setting forth a proposal to the qualified electors of the City and County of San Francisco to amend the Charter of said City and County by amending Section 42 thereof, Recreation Commission, by prescribing the terms of office of the members of the Recreation Commission.

The Board of Supervisors of the City and County of San Francisco hereby submits to the electors of the City and County of San Francisco, at the general municipal elec-

tion to be held on November 2, 1943, a proposal to amend the Charter of said City and County by amending Section 42 thereof, so that the same shall read as follows:

### **RECREATION DEPARTMENT**

Section 42. The recreation department shall be under the management of a recreation commission consisting of seven members, five of whom shall be appointed by the mayor, and shall serve without compensation. Three of the members appointed by the mayor shall be men and two shall be women. The superintendent of schools and the superintendent of parks shall be members of the commission ex officio.

The term of each of the commissioners of said department shall be four (4) years, provided that all of the commissioners in office on the effective date of this amendment shall be continued in their respective offices until their respective terms shall have expired. Upon the expiration of the term of each commissioner the mayor shall appoint his or her successor for a further term of four (4) years. The mayor shall have the power to fill all vacancies occurring on said commission and said appointments shall be for the unexpired term of the office vacated.

The recreation commission shall appoint a superintendent, who shall be the chief executive officer of said department, and who shall hold office at the pleasure of the commission.

The commisioners shall have the complete and exclusive control, management and direction of all playgrounds, recreation centers, and all other recreation facilities, now or hereafter placed under charge of the commission, including exclusive right to erect and to superintend the erection of buildings and structures thereon, and to construct new playgrounds and recreation centers, except as in the charter otherwise provided.

### **CHARTER AMENDMENT NO. 7**

Describing and setting forth a proposal to the qualified electors of the City and County of San Francisco to amend the Charter of said City and County by adding a new section thereto to be designated as Section 9.1 thereof, authorizing the Board of Supervisors to offer rewards for the apprehension and conviction of any person charged



with or suspected of having committed a felony in the City and County of San Francisco.

The Board of Supervisors of the City and County of San Francisco hereby submits to the qualified electors of said City and County, at an election to be held on the second day of November, 1943, a proposal to amend the Charter of said City and County, by adding a new section to said charter to be known as Section 9.1, authorizing the Board of Supervisors to offer rewards for the apprehension and conviction of any person who may have committed a felony in the City and County of San Francisco, and to authorize the payment thereof.

### **REWARD FOR APPREHENSION AND CONVICTION OF FELONS**

Section 9.1. The Board of Supervisors shall have power to include in the annual budget and appropriation ordinance for its department each year an item of Five Thousand (\$5,000.00) Dollars, and the amount of said appropriation or any part thereof may be offered as a reward for the apprehension and conviction of any person who may have committed a felony in the City and County of San Francisco. Said reward shall be offered by the Board of Supervisors and the amount of said reward shall be specified in a resolution adopted by said Board of Supervisors authorizing the offering and payment of said reward. No such resolution shall be adopted until the Chief of the Police Department shall approve the offering of said reward.

### **PROPOSITION — ORDINANCE No. 8**

**AMENDING SECTION 40 OF CHAPTER IX, PUBLIC UTILITIES CODE.** Permitting operation of electric street cars by one person, on designated streets excepting Market Street, for duration of war.

To the Board of Supervisors of the City and County of San Francisco:

The undersigned, members of your Board, hereby propose that the annexed ordinance to amend Section 40 of Chapter IX of the Public Utilities Code (Ordinance No. 15.0917) permitting the operation of street railway cars by one person for the period and under the conditions set forth therein be submitted to the electors of the City and County of San Francisco at the next general election to be held in said City and County, to-wit, the general municipal election to be held on November 2, 1943, and

that the Registrar of Voters take all steps necessary to submit said ordinance to said electors, as provided by law.

Said proposed ordinance is as follows, to-wit:

Amending Section 40 of Chapter IX of the Public Utilities Code (Ordinance No. 15.0917) permitting the operation of street railway cars by one person until the termination of the war, and specifying the age and qualifications of such persons so operating street railway cars.

Be It Ordained by the People of the City and County of San Francisco as follows:

Section 40 of Chapter IX of the Public Utilities Code (Ordinance No. 15.0917) is hereby amended by adding thereto the following sections:

Section 3. For the duration and until the termination of the present war, or until the Board of Supervisors by ordinance shall determine that the manpower shortage no longer exists, street railway cars (except cable cars), while carrying passengers in the City and County of San Francisco (except on Market Street), may be operated by one experienced person under the following conditions:

(a) Any person operating such a street car must be an adult of not less than 21 years of age and possess the qualifications provided in Section 52 of Chapter IX of the Public Utilities Code.

(b) Such street cars must be equipped with the generally accepted so-called one-man car safety devices.

(c) Such street cars may be operated on the following lines of the Market Street Railway Company: No. 19—Polk-Larkin Streets; No. 25—San Bruno Avenue; No. 26—San Jose Avenue; No. 27—Bryant Street; No. 36—Folsom Street; No. 41—Second Street; No. 42—Sansome Street.

(d) Such street cars may be operated excepting between the hours of 7:00 A.M. and 9:00 A.M., and 4:00 P.M. and 6:30 P.M. on Monday to Friday inclusive on the following lines of the Market Street Railway Company: No. 11—Mission and 24th Streets; No. 12—Ingleside and Ocean Avenue; No. 14—Mission Street; No. 15—Third and Kearny Streets; No. 20—4th-Ellis-O'Farrell Streets; No. 22—Fillmore Street; No. 40—San Mateo Interurban.

Section 4. Each and all of the provisions of any ordinance conflicting with the provisions of Section 3 hereof are hereby suspended for the duration and until the termination of the present war, or until the Board of Supervisors by ordinance shall determine that the manpower shortage no longer exists.

# **Vote NO** ON CHARTER AMENDMENT NUMBER **1**

Charter amendment number 1 will provide greatly increased pension benefits and privileges for members of the fire department, *including non-fire fighting employees*. The proposed amendment authorizes retirement at half pay after only 25 years' service, extends the pension to the widow for life or until remarried and to the children until the youngest child reaches the age of 18 years, not only for death in line of duty—which is taken care of now—but for service as well. The existing 70-year mandatory retirement age limit has been omitted, leaving it up to the individual member to retire at his option. *The firemen now enjoy full membership in the City's retirement fund for City employees.*

## **CITY'S COST INCREASED TO 15.18 PERCENT OF PAYROLL**

The money required to meet the increased pension benefits will be paid out of taxes by the City. The majority of the members of the fire department will pay no more—and some will pay less—than they do now. The members will pay 5 percent of their salary to the pension fund under this measure.

The proposed pension system ultimately will cost the taxpayers \$517,704 annually or 15.18 percent of fire department salaries, according to the official report. The official report shows that the comparable cost to the City for the pensions of these men is 8.98 percent of salaries under existing charter provisions.

The City now is paying \$3,077,248 for all City employees' pensions. The amount raised by taxes represents 28 cents in the tax rate.

## **PENSIONS FOR INJURIES ARE PAID NOW**

*Pensions for disability or death in line of duty are not involved, as the existing pension system provides adequate protection in such cases. This proposed amendment will provide a costly service pension, and force the greater part of the cost on the taxpayers.*

*The City now provides adequate protection for widows and dependents of firemen killed in line of duty or who die from injuries received in line of duty. Under the terms of this amendment, pensions of firemen will be continued to widows and dependents for service alone.*



Can there be any distinction drawn between service in this one case and service of the other 14,000 City and County employees? The answer obviously is no. If this principle is extended to the other 14,000 City employees the cost to the taxpayers will be increased several million dollars.

An amendment similar to this one, affecting the Police, submitted with this measure and later withdrawn because of possible legal objections, is sure to go on the ballot next year. The cost to extend pension benefits of charter amendment number 1 to the 1,300 police personnel would have been \$1,134,000 in 1940 before the salary raise of last fall, according to the official report.

### **\$6,000,000 DEFICIT IN FIRE PENSION FUND**

The City's retirement board reports an *unfunded deficit* in the existing firemen's pension system of \$5,958,223 on July 1, 1943. This deficit is increasing at the rate of several hundred thousand dollars yearly. *The City must meet this liability* when the present members of the system retire. Charter amendment number 1 makes no provision for funding this deficit or for setting up reserves to provide for heavy payments in the future, neither does the amendment make any provision for preventing this deficit from greatly increasing in the years ahead.

### **PEOPLE VOTED DOWN SIMILAR PLAN IN 1938**

The firemen and the policemen sought the voters' approval to measures closely resembling charter amendment number 1 in November, 1938. *The voters rejected these proposals.*

*Charter amendment number 1 is unnecessary, sets a bad precedent for other groups of City employees, is too liberal, and places too much of the burden on the taxpayers.*

The sewerage system in San Francisco is in a defective and dangerous condition.

Adoption of Charter Amendment No. 2 will insure, for several years, a portion of the funds necessary for sewer repairs and reconstruction. Many sewers are in filled ground and this condition gives rise to numerous sumps throughout the whole system. These sumps create pools of stagnant sewage which do not circulate and which constitute a health menace in the neighborhood.

Dr. Charles Gilman Hyde, Consulting Sanitary Engineer, of the University of California and notable authority, declares: "The waters of San Francisco Bay, along the entire shore line from the San Mateo Boundary to and including Aquatic Park are **GROSSLY POLLUTED WITH SEWAGE**. The entire shore line described above is one of the most **OBNOXIOUS** in the United States. All beaches, including Aquatic Park, have been **QUARANTINED AGAINST BATHING** by the Department of Public Health."

An inadequate sewerage and sewage disposal system is a serious menace to public health, from which rat infestation and bubonic plague can result.

Adequate provision is now made for the establishment and maintenance of parks, playgrounds and other recreational facilities. How equally necessary it is to **PRESERVE THE HEALTH**, particularly of children, from the hidden menace which lurks in an antiquated, dilapidated disease-breeding sewer.

# Argument in Favor of Charter Amendment No. 4

## *Increasing the Salary of the Captain of Traffic*

Charter Amendment No. 4 re-writes section 35.5 of the Charter, but the only change it proposes is to increase the salary of the Captain of Traffic to \$5300.00 per year.

Traffic is a major problem which confronts the City and County of San Francisco. The Captain of Traffic is charged with responsibility for the enforcement of traffic laws and traffic ordinances. In normal times he has a personnel of approximately 250 men and even with wartime restrictions the strength of the bureau is over 190.

The Traffic Bureau has an accident prevention unit, a motorcycle unit, a motor tricycle unit, a foot unit, and other special investigative branches. It is charged with the safety of vehicular and pedestrian traffic upon our highways and it must operate on a 24-hour day basis.

The Captain of Traffic is required to keep in touch with all the phases of traffic control. He can have no stated hours because his personal attention to traffic problems is required at varying times of the day and night. He must possess a sound background of police training and education, particularly in the field of traffic.

The Police Commission and the Chief of Police have given careful consideration to this important office and it is their reasoned opinion that the same salary should be attached thereto as is now set forth in the Charter for the office of the Captain of Inspectors. The latter captain receives an annual salary of \$5300.00 per year, and public interest demands that a like salary should be attached to the office of the Captain of Traffic

We realize that every man, woman and child has a deep and abiding interest in traffic safety. We feel that the proposed change will be instrumental in promoting greater safety on our public highways, and we therefore earnestly recommend a YES vote on Charter Amendment No. 4.

# Vote "NO" ON PROPOSITION NUMBER 8

## ONE-MAN CARS

The Board of Supervisors of the City and County of San Francisco urges you to VOTE AGAINST ONE-MAN CARS for the following reasons:

The Market Street Railway Company is now urging the voters to set aside the safety ordinance prohibiting the operation of ONE-MAN CARS. The ordinance prohibiting One-Man Cars was adopted by the PEOPLE in 1935 and after the Market Street Railway Company carried the litigation to the highest courts in the land, the law was upheld by the United States Supreme Court as a VALID AND REASONABLE SAFETY REGULATION.

The Market Street Railway Company claims that due to a manpower shortage it is necessary that they be privileged to operate One-Man cars on the streets of San Francisco. Any manpower shortage that may exist on the lines of the Market Street Railway Company has been brought about by the failure and refusal of the Company to pay its operators a wage equal to that paid on the Municipal Railway for similar work. The Market Street Railway Company not only refused to join with its employees in an application to the National War Labor Board for an increased wage, but is at the present time stubbornly contesting an application made by its employees for an increased wage to equal that paid to operators on the Municipal Lines.

FOR THE YEAR ENDING JUNE, 1943, THE MARKET STREET RAILWAY COMPANY MADE A NET PROFIT OF \$1,193,604 FROM THE OPERATION OF TWO-MAN CARS.

The Market Street Railway Company is attempting to use the war emergency as an excuse to obtain the privilege of operating ONE-MAN CARS for the sole purpose of INCREASING ITS PROFITS and in this process they intend to impose a DOUBLE BURDEN on their already over-worked employees.

The Market Street Railway Company represents that One-Man Cars are necessary for better service. DOES BETTER AND FASTER SERVICE RESULT BY REMOVING THE CONDUCTOR FROM A STREET CAR AND ADDING HIS DUTIES TO THOSE OF THE MOTORMAN?

The present service of the Market Street Railway is poor enough. Let's not make it worse by the introduction of unsafe and out-moded ONE-MAN CARS!

Don't be misled by Company PROPAGANDA or THREATS relative to impending actions of the Office of Defense Transportation. The Market Street Railway Company has no secret information from the Office of Defense Transportation, nor has any other person or agency. If the Market Street Railway Company were sure that the Office of Defense Transportation intended to suspend the prohibition against One-Man Cars, the Company would not now be expending time, effort and money in an endeavor to have the People sanction the proposal for the operation of One-Man Cars.

Everyone in San Francisco knows the inconveniences of present day street car riding. Our street cars are carrying about three times the load they can bear.

We get by somehow by using every available entrance to cars. One-man cars would require single file loading and unloading. They would retard the progress of our already slow moving cars.

## **One-Man Cars Would Mean That Hundreds of S F. boys now in the armed forces would have no jobs to come home to.**

We promised our boys that their jobs would be waiting for them when they come back home. If we vote for one-man cars we are voting to do away with hundreds of jobs we are supposed to be holding in trust for our soldiers, sailors and marines.

## **Is This the Way to Keep Faith With the Boys Who Are Fighting for Us?**

Don't let anyone tell you that this is an "emergency" measure. The Market Street Railway has been trying to get one-man cars here for 10 years.

In 1935 the people of San Francisco turned down one-man cars by a vote of three to one. The Market Street Railway challenged our decision but we were sustained in a long court battle by the U. S. Court of Appeals.

In its present attempt to get one-man cars, the Market Street Railway is opposed by our Board of Supervisors.

The company has tried for many years to give us the short end of every deal.

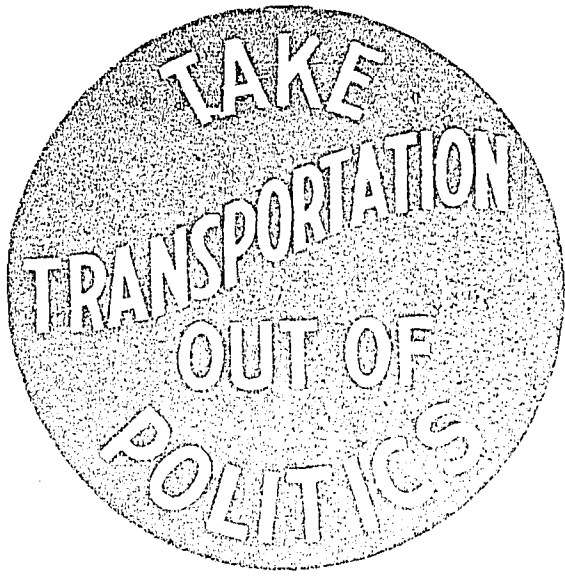

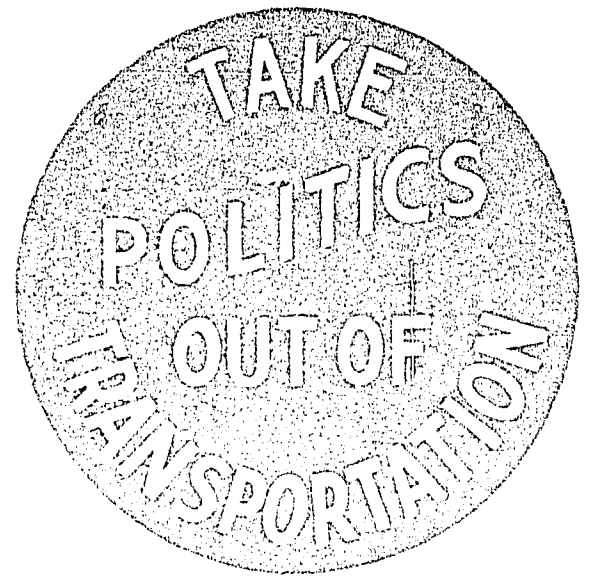

### **One-Man Trolley Operation Backed**

Robert O. Crowe, director of the Office of Defense Transportation division of local transport, today indorsed the proposed charter amendment at the Nov. 2 election which would permit the Market Street Railway to operate one-man cars for the duration of the war.

"There is no question that one-man operation of Market Street Railway cars would save manpower and not interfere with the safe operation of street cars on the lines proposed by the Market Street Railway," Mr. Crowe said.

He said the regional ODT office has had considerable correspondence with the mayor's office on one-man cars and feasibility of the plan and its value in helping solve the local transportation problem.

## **Wage Increases Not Involved**

Wage increases are not involved. If, through the orderly processes established by the Federal Government, an increase in pay is granted, and that increase results in sufficient additional employment, the Supervisors may, on these grounds, declare the emergency ended, and restore the full operation of the existing ordinance.

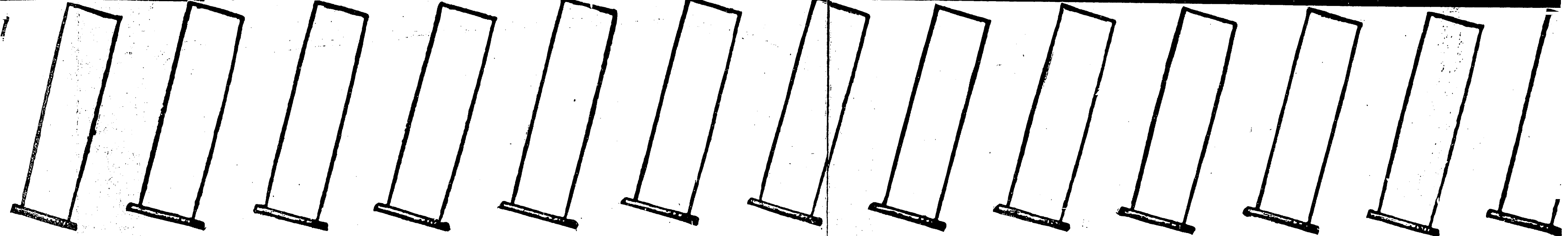

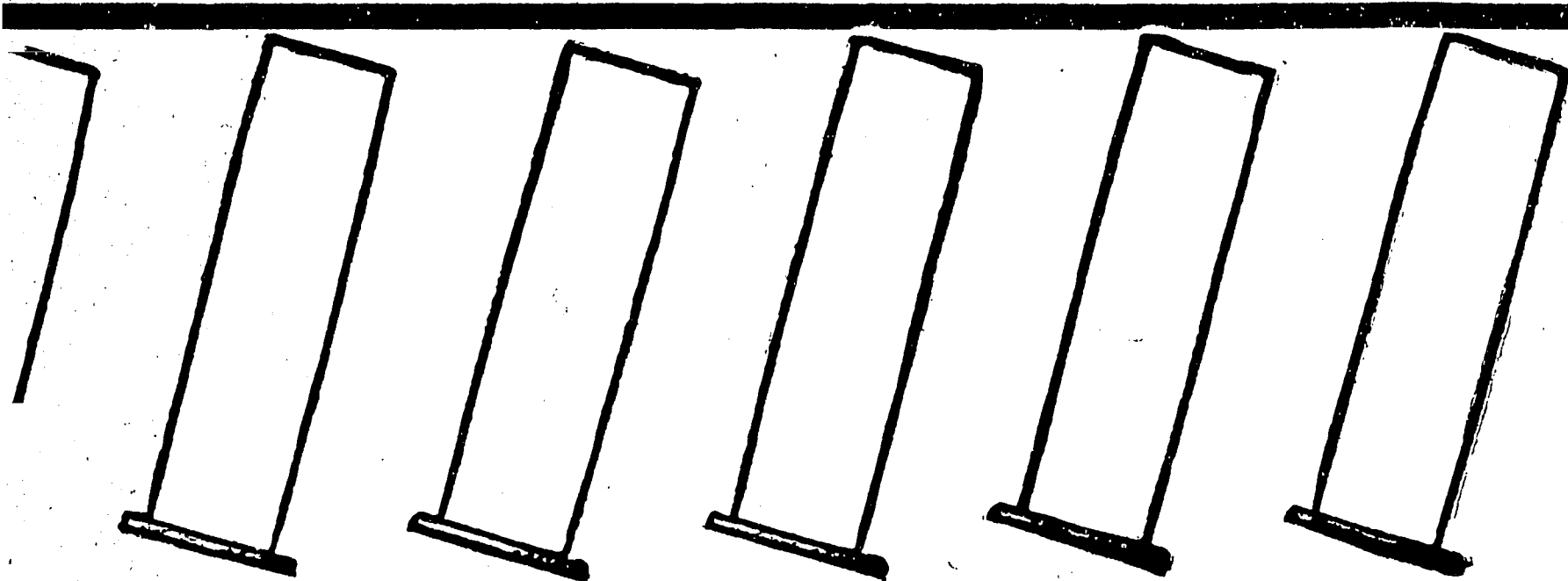
## DIRECTIONS FOR VOTING





