No. 426-59 CALLING AND PROVIDING FOR A SPE-CIAL ELECTION TO BE HELD IN THE CITY AND COUNTY OF SAN FRANCISCO ON TUESDAY, NOVEMBER 3, 1959, FOR THE PURPOSE OF SUBMITTING TO THE VOTERS OF THE CITY AND COUNTY OF SAN FRANCISCO PROPOSITIONS TO INCUR BONDED DEBTS OF THE CITY AND COUNTY FOR THE ACQUISITION, CONSTRUCTION AND COMPLETION BY THE CITY AND COUNTY OF SAN FRAN-CISCO OF THE FOLLOWING MUNICIPAL IMPROVEMENTS, TO WIT: \$7,575,000 FOR CIVIC CENTER AUDITORIUM IMPROVEMENT; \$2,-970,000 FOR FERRY PARK; \$1,800,000 FOR PALACE OF FINE ARTS; AND THAT THE ESTIMATED COST TO THE CITY AND COUNTY OF SAID MUNICIPAL IMPROVEMENTS IS AND WILL BE TOO GREAT TO BE PAID OUT OF THE ORDINARY ANNUAL INCOME AND REVE-NUE OF THE CITY AND COUNTY AND WILL REQUIRE EXPENDI-TURES GREATER THAN THE AMOUNTS ALLOWED THEREFOR BY THE ANNUAL TAX LEVY; ALL IN ORDER TO DO AND PERFORM ANY AND ALL OF THE MATTERS HEREINABOVE REFERRED TO; FIXING RATE OF INTEREST OF SAID BONDS AND PROVIDING FOR THE LEVY AND COLLECTION OF TAXES TO PAY BOTH PRINCIPAL AND INTEREST THEREOF, PRESCRIBING NOTICE TO BE GIVEN OF SUCH ELECTION AND CONSOLIDATING THE SPECIAL ELEC-TION WITH THE GENERAL MUNICIPAL ELECTION.

Be it ordained by the People of the City and County of San Francisco: Section 1. A special election is hereby called and ordered to be held in the City and County of San Francisco on Tuesday, the 3rd day of November, 1959, for the purpose of submitting to the electors of said city and county propositions to incur bonded indebtedness of the City and County of San Francisco for the acquisition, construction and completion by the city and county of the hereinafter described municipal improvements in the amounts and for the purposes stated:

(a) CIVIC CENTER AUDITORIUM IMPROVEMENT BONDS, 1959.

\$7,575,000 to pay the cost of the alterations, additions, remodeling and improvements to the Civic Center Auditorium on the exterior and interior thereof, together with furniture, fixtures, equipment, apparatus, escalators, elevators, fire protection, sprinkling systems, plumbing, lighting, power, electrical work, heating and air conditioning systems, public address systems, acoustical treatment, and all other works, properties, or structures necessary or convenient to provide a complete remodeling and improvements to the Civic Center Auditorium.

(b) FERRY PARK BONDS, 1959.

\$2,970,000 to pay the cost of a public park located adjacent to the Embarcadero and near the Ferry Building in the City and County of San Francisco, all lands and improvements thereon necessary for said park purposes, the clearance and development of said lands, the construction, including paving, lawns, trees, shrubs, curbing, fountains, recreational facilities, convenience stations, lighting, relocation of transportation lines, conduits, trolleys, terminal, a terminal site therein, other pertinent facilities, and all other works, properties and structures necessary or convenient for a public park.

(c) PALACE OF FINE ARTS, 1959.

\$1,800,000 to pay the cost of additions, betterments, improvements and reconstruction of the Palace of Fine Arts within the City and County of San Francisco, to provide within the structure for a small theatre, music hall, an area for work and exhibit space for visual, graphic and plastic arts, convention activities, youth activities and recreational activities, studio, office space, and all furnishings, equipment, works, properties and structures necessary or convenient for the additions, betterments, improvements and reconstruction of the Palace of Fine Arts.

That the total estimated cost of said municipal improvement as now contemplated is \$5,800,000, whereof \$2,000,000 has been contributed to the city and county for this specific purpose by Walter S. Johnson and \$2,000,000 contributed by the State of California from the State Park Commission and the \$1,800,000 from the sale of bonds authorized by the electors under this bond proceedings will constitute the sources of funds for the improvement. The estimated cost of said municipal improvement as set forth herein is not to be deemed to constitute a limitation or condition upon the issuance of bonds in the said amount of \$1,800,000, and the Board of Supervisors reserves the right to reduce the scope of the project to an estimated cost of not to exceed the principal amount of said bonds proposed to be issued or in the alternative to an estimated cost equal to the principal amount of said bonds plus any additional moneys then available from said contribution or contributions.

Section 2. The estimated costs of the municipal improvements described in Section 1 hereof were fixed by the Board of Supervisors by the following resolutions and in the amounts specified:

Civic Center Auditorium Bonds, Resolution No. 571-59, \$7,575,000; Ferry Park Bonds, Resolution No. 573-59, \$2,970,000; Palace of Fine Arts Bonds, Resolution No. 572-59, \$1,800,000.

That all of said resolutions were passed by more than two-thirds of the Board of Supervisors and approved by the Mayor, and in each of said resolutions it was recited and found that the sums of money specified were too great to be paid out of the ordinary annual income and revenue of the city and county in addition to the other annual expenses thereof or other funds derived from taxes levied for those purposes and will require expenditures greater than the amounts allowed therefor by the annual tax levy.

The method and manner of payment of the estimated costs of the municipal improvements described herein are by the issuance of bonds of the City and County of San Francisco in the principal amounts specified.

Said estimates of cost as set forth in said resolutions, and each thereof, are hereby adopted and determined to be the estimated costs of said improvements, and each thereof.

Section 3. The special election hereby called and ordered to be held shall be held and conducted and the votes thereat received and canvassed, and the returns thereof made and the results thereof ascertained, determined and declared as herein provided and in all particulars not herein recited said election shall be held according to the laws of the State of California providing for and governing elections in the City and County of San Francisco, and the polls for such election shall be and remain open during the time required by said laws.

Section 4. The said special election hereby called shall be and hereby is consolidated with the General Municipal Election to be held Tuesday, November 3, 1959, and the voting precincts, polling places and officers of election for said General Municipal Election be and the same are hereby adopted, established, designated and named, respectively, as the voting precincts, polling places and officers of election for said special election hereby called, and as specifically set forth, in the official publication, by the Registrar of Voters of precincts, polling places and election officers for the said General Municipal Election.

The ballots to be used at said special election shall be the ballots to be used at said General Municipal Election and reference is hereby made to the notice of election setting forth the voting precincts, polling places and officers of election by the Registrar of Voters for the General Municipal Election to be published in the San Francisco Examiner on or about October 19, 1959.

Section 5. On the ballots to be used at such special election and on the voting machines used at said special election, in addition to any other matter required by law to be printed thereon, shall appear thereon the following, each to be separately stated, and appear upon the ballots as separate propositions:

(a) "Civic Center Auditorium Improvement Bonds, 1959. To incur a bonded indebtedness of \$7.575,000 for the alteration and remodeling of the Civic Center Auditorium in San Francisco."

(b) "Ferry Park Bonds, 1959. To incur a bonded indebtedness of \$2,970,-000 for the acquisition of lands and improvements thereon and construction of a park and recreational facilities at the Embarcadero near the Ferry Building in San Francisco."

(c) "Palace of Fine Arts Bonds, 1959. To incur a bonded indebtedness of \$1,800,000 for the reconstruction of the Palace of Fine Arts at the Marina in San Francisco."

To vote for any proposition where ballots are used, and to incur the bonded indebtedness to the amount of and for the purpose stated herein, stamp a cross (x) in the blank space to the right of the word "Yes." To vote against any proposition and thereby refuse to authorize the incurring of a bonded indebtedness to the amount of and for the purposes stated herein, stamp a cross (x) in the blank space to the right of the word "No."

Where voting machines are used at said special election said voting machines shall be so arranged that any qualified elector may vote for any proposition by pulling down a lever over the word "Yes" under or near a statement of the proposed proposition appearing on cardboard, paper or other material placed on the front of the machine, and said act shall constitute a vote for the proposition, and by pulling down a lever over the word "No" under or near a statement of the proposed proposition appearing on cardboard, paper or other material placed on the front of the machine, shall constitute a vote against the proposition. Said voting machines and the preparation of the same shall comply in all respects with the provisions of law. Section 6. If at such special election it shall appear that two-thirds of all the voters voting on any proposition voted in favor of and authorized the incurring of a bonded indebtedness for the purposes set forth in said proposition, then such proposition shall have been accepted by the electors, and bonds shall be issued to defray the cost of the municipal improvements described herein. Such bonds shall be of the form and character known as "serials," and shall bear interest at a rate not to exceed 6 per centum per annum, payable semi-annually.

The votes cast for and against each of said respective propositions shall be counted separately and when two-thirds of the qualified electors, voting on any one of such propositions, vote in favor thereof, such proposition shall be deemed adopted.

Section 7. For the purpose of paying the principal and interest on said bonds the Board of Supervisors shall, at the time of fixing the general tax levy and in the manner for such general tax levy provided, levy and collect annually each year until such bonds are paid, or until there is a sum in the Treasury of said city and county set apart for that purpose to meet all sums coming due for the principal and interest on said bonds, a tax sufficient to pay the annual interest on such bonds as the same become due and also such part of the principal thereof as shall become due before the proceeds of a tax levied at the time for making the next general tax levy can be made available for the payment of such principal.

Section 8. This ordinance shall be published once a day for at least seven (7) days in the San Francisco Examiner, a newspaper published daily in the City and County of San Francisco, being the official newspaper of said city and county and such publication shall constitute notice of said election and no other notice of the election hereby called need be given.

ARGUMENT FOR PROPOSITION A

Rehabilitation of Civic Auditorium Vote Yes on Proposition A

The convention business which amounts to over \$780,000,000 per year in San Francisco's overall economy is now being jeopardized because the Civic Auditorium, completed in 1914, is unable to perform the function for which it was created.

Today the conventions which bring millions of dollars a year to those cities able to successfully compete for them demand facilities designed to accommodate their modern diversified programs and expanded facilities in keeping with the tremendous growth of their activities. Other major cities across the nation aware of this, have already met this situation with foresight and courage and have completed or are presently constructing modern new facilities to cope with it, among these are Philadelphia, Detroit, Los Angeles, Portland, Las Vegas and Miami, to mention a few.

The present Civic Auditorium structure has in its favor an unsurpassed location, a fine classic design and sound structure. These are to be retained for the important savings they represent.

The entire interior must be rehabilitated and reconstructed to be made functional in keeping with similar facilities in other cities. The cost is estimated at \$7,575,000 which is the amount of the bond issue. Briefly, it will rebuild the main arena and convert the upper floors into 60 usable meeting, lecture and administrative units of varying sizes adjustable to conform to the different needs of different users. Escalators and modern elevators and material movers are to be installed. Air and temperature controlling equipment and up-to-date convention staging, lighting and servicing additions are to be constructed. Similar rehabilitation is to be carried out in the two smaller halls, Polk and Larkin, to make them fully operational. The classic exterior will be given modern treatments, creating features of beauty, utility and safety in conformity with the most advanced planning

for public buildings.

As the Civic Auditorium operates at a profit which can be expected to increase under a more expanded and efficient operation, the cost of this project will eventually be reimbursed to the city from revenues. Hence it is self-liquidating and finally will represent no cost to the taxpayers.

Last year revenues increased \$67,151.18 over the previous year's totals indicating the current rate of climb in convention activity in San Francisco. But even more important, it is the key to the millions of dollars that visitors and conventioneers distribute each year among the cities who host them.

Last year San Francisco's share of this totaled over \$36,500,000. Our share during the coming years will be largely dependent on our ability to compete with the facilities offered by other major cities. Conceivably it could reach \$50,000,000 by 1965.

Ferry Park Bonds, 1959. To incur a bonded debt in the sum of \$2,970,000 for the acquisition, construction and completion of a public park located adjacent to the Embarcadero and near the Ferry Building in the City and County of San Francisco.

Should the proposed \$2,970,000 Ferry Park Bonds, 1959, be authorized, and when all bonds shall have been issued on a 15 year basis, and after consideration of the interest rates related to current municipal bond sales, and after evaluation of estimated maintenance expense at current price levels contained in a report submitted by the Recreation and Park Commission, and using the 1959-1960 assessment roll as the basis for calculating the effect upon the tax rate, in my opinion, the approximate costs would be as follows:

The provisions of chapter 2386 of the 1957 statutes of the State of California appropriated \$2,000,000 toward the total estimated cost of rehabilitating the Palace of Fine Arts expenditure of which was conditioned upon the city and county conveying, without cost, to the State, all the land and improvements in the City and County of San Francisco known as the San Francisco Palace of Fine Arts, totaling approximately 13¹/₂ acres.

Chapter 2386 also provided that after repair and rehabilitation, the State Park Commission may lease the property to the City and County of San Francisco for uses as specified in this bond proposition.

If the facility is leased to the city and county, based upon a report by the Recreation and Park Commission, it is my opinion that operating and maintenance costs will be approximately \$193,000 annually which is equivalent to one and four-tenths (1.4) cents in the tax rate, and which would be reduced by one-tenth (0.1) of one cent for each \$14,000 of annual revenue. It is my understanding that the rehabilitated facility would be revenue producing, but in my opinion there are not available sufficient facts upon which to base an estimate thereof.

Section 45. An art commission for the city and county is hereby created, consisting of ten members appointed by the mayor and six ex officio members. The ex officio members shall be the mayor and the chairmen of the following boards and commissions: Public library, recreation and park, city planning, de Young Memorial Museum and California Palace of the Legion of Honor. The mayor shall appoint three lay members, and an artistpainter, an artist-sculptor, a musician, a litterateur, two architects and one landscape architect. In appointing the seven professional members, the mayor shall solicit nominations from architectural, art, musical, literary and other cultural organizations of the city.

The first appointments by the mayor shall be made not later than the 15th day of January, 1932, and shall be for the following terms, which shall expire at twelve o'clock noon on the 15th day of January in the respective years: One landscape architect and one lay member, one-year terms; one artist-sculptor and one architect, two-year terms; one musician and one lay member, three-year terms; one litterateur and one architect, four-year terms; and one artist-painter and one lay member, five-year terms. Upon the expiration of the terms, all successive appointments shall be for a period of five years.

The members of the commission shall serve without compensation. No member of this commission shall receive from the city and county, or from any trust, donation, or legacy, any compensation for any service as an artist for the benefit of the city and county.

A quorum for the transaction of official business of the art commission shall consist of six members thereof.

All claims for money or damages against the city and county must be filed in accordance with the general law of the State of California applicable to the filing of claims against local public entities; otherwise no suit for money or damages may be brought against the city and county.

All claims heretofore presented within the time prescribed by the general law of the State of California and which substantially complied therewith at the time of their presentation shall be deemed to have been properly presented.

This section applies only to claims relating to causes of action arising subsequent to the effective date of Chapter 1724, California Legislature, 1959 Regular Session.

The Board of Supervisors of the City and County of San Francisco hereby submits to the qualified electors of said city and county at an election to be held therein on November 3, 1959, a proposal to amend the charter of said city and county by adding Section 222.1 thereto to read as follows: Section 222.1. A supervisor, officer or employee shall not be deemed interested in or in the performance of any contract, work, business, or the sale of any article, the expense, price or consideration of which is payable from the treasury, within the meaning of Section 222, unless such contract, work, business or sale is awarded, entered into, or authorized by him in his capacity as supervisor, officer or employee, or by an officer or employee under his supervision and control, or by a board or commission of which he is a member.

A supervisor or officer of the city and county shall not be deemed interested in any such contract, work, business or sale awarded, entered into or authorized by a board or commission of which he is a member if he has only a remote interest therein and the fact of such interest is disclosed to the board or commission of which he is a member and noted in its official records and the board or commission authorizes, approves, or ratifies the contract in good faith by a vote of its membership sufficient for the purpose without counting the vote or votes of the supervisor, officer or member with the remote interest, unless the contract must be awarded to the highest or lowest responsible bidder as the case may be on a particular day and the vote of such supervisor, officer or member is necessary to a quorum on that day.

As used in this section "remote interest" means:

(1) The ownership of less than five per cent of the shares of a corporation for profit;

(2) That of a nonsalaried officer of a nonprofit corporation;

(3) That of an officer in being reimbursed for his actual and necessary expenses incurred in the performance of official duty;

(4) That of an employee of the contracting party having ten or more other employees; provided, that the supervisor or officer was an employee of said contracting party for at least three years prior to his initially accepting such office;

(5) That of a parent in the earnings of his minor child for personal services;

(6) That of a landlord or tenant of the contracting party;

(7) That of an attorney of the contracting party; or

(S) Except as to supervisors, such other interest or relationship other than those set forth in (1) to (7) above as may hereafter be designated by a vote of two thirds of the members of the Board of Supervisors.

All contracts, work, business or sales herein mentioned heretofore awarded, entered into or authorized by any board or commission of the City and County of San Francisco in which a supervisor, officer or member had a remote interest as hereinabove defined are hereby ratified and confirmed.

The provisions of this section shall not be applicable to any supervisor, officer or employee who influences or attempts to influence the award, execution or authorization of any contract, work, business or sale, the expense, price or consideration of which is payable from the treasury, in which he has a direct or indirect interest.

((Every person employed in the city and county service shall, after one year's service, be allowed a vacation with pay of two calendar weeks, annually, as long as he continues in his employment, provided that, after five year's service every person so employed shall be allowed, as long as he continues in his employment, a vacation with pay of fifteen days, annually, calculated as hereinafter provided. For the purpose of computing vacation time, each employee shall be considered to work five days each week and holidays occurring within any such five days shall be considered as working days. For the purpose of computing vacation pay, no employee shall be considered to work more than five days each week and pay for holidays occurring on any of such fifteen days shall be computed on a straight time basis. Vacation pay for employees working less than five days each week shall be computed proportionately. The time when vacations are taken shall be at the convenience of the department with due regard for seniority.))

((This section shall become effective on January 1st, 1951.))

Every person employed in the city and county service shall be allowed a vacation with pay annually, as long as he continues in his employment, as follows:

1. After one year's continuous service, ten working days.

2. After five years' continuous service, fifteen working days.

Section 151.4.1. Employees may elect not to take their entire vacation in any one year and in such event may accumulate the days allowable and not taken for use at some future time, provided, however, that no employee may accumulate unused vacation allowance in excess of thirty working days regardless of length of service.

Section 151.4.2. In computing vacation pay, no employee shall be considered to work more than five days each week. Vacation pay for employees working less than a five-day week shall be computed proportionately.

Section 151.4.3. If a holiday occurs during such employee's vacation, and the employee would as a matter of law have been entitled to said day as a regular day off, such holiday shall not be considered a day of vacation chargeable to the employee's vacation allowance provided for in Section 151.4.

Section 151.4.4. The time when vacations are to be taken shall be at the convenience of the department head with due regard for seniority.

Section 151.4.5. An employee with one year or more of service who ceases to be employed by the city and county and who has neither received nor waived his current annual vacation allowance provided for in Section 151.4 shall receive a pro rata payment for all service performed since January 1 of the calendar year in which he ceases to be employed, together with an amount equivalent to any accumulated vacation allowance due him.

Section 151.4.6. The board of supervisors shall enact any and all ordinances necessary to administer, interpret and regulate the provisions of Sections 151.4 to and including 151.4.5.

PROPOSITION J

Amends Section 171.1.1; relating to retirement benefits of operating engineers, provides that all so employed on July 1, 1960 and all subsequently employed who meet age requirements of fire department, be deemed members of fire department for retirement purposes.

CHARTER AMENDMENT

Describing and setting forth a proposal to the qualified electors of the City and County of San Francisco to amend the charter of said city and county by amending Section 171.1.1 thereof, to provide for the inclusion of chief operating engineers, operating engineers and junior operating engineers in the Fire Department as members of the Fire Department.

The Board of Supervisors of the City and County of San Francisco hereby submits to the qualified electors of said city and county at an election to be held therein on November 3, 1959, a proposal to amend the charter of said city and county by amending Section 171.1.1 thereof, so that the same shall read as follows:

NOTE: Additions or substitutions are indicated by **bold-face type**; deletions are indicated by ((double parentheses)).

Section 171.1.1. The following words and phrases as used in this section, unless a different meaning is plainly required by the context, shall have the following meaning:

"Retirement allowance," "death allowance" or "allowance," shall mean equal monthly payments, beginning to accrue upon the date of retirement, or upon the day following the date of death, as the case may be, and continuing for life unless a different term of payment is definitely provided by the context.

"Compensation," as distinguished from benefits under the Workmen's Compensation Insurance and Safety Act of the State of California, shall mean the remuneration payable in cash, by the city and county, without deduction except for absence from duty, for time during which the individual receiving such remuneration is a member of the fire department, but excluding remuneration paid for overtime.

"Compensation earnable" shall mean the compensation which would have been earned had the member received compensation without interruption throughout the period under consideration and at the rates of remuneration attached at that time to the ranks or positions held by him during such period, it being assumed that during any absence he was in the rank or position held by him at the beginning of the absence, and that prior to becoming a member of the fire department he was in the rank or position first held by him in such department.

"Benefit" shall include "allowance," "retirement allowance," "death allowance" and "death benefit."

"Final compensation" shall mean the average monthly compensation earnable by a member during the three years immediately preceding his retirement, or death before retirement.

For the purpose of the retirement system and of this section, the terms "member of the fire department," "member of the department," or "member" shall mean any officer or employee of the fire department excluding such officers and employees as are members of the retirement system under section 169 of the charter, who was or shall be subject to the charter provisions governing entrance requirements of members of the uniformed force of said department, and said terms further shall mean, from the effective date of their employment in said department, persons employed on the effective date hereof, regardless of age, or employed after said date at an age not greater than the maximum age then prescribed for entrance into employment in said uniformed force, to perform the duties now performed by members of the salvage corps in the fire department, or duties now performed under the titles of pilot of fireboats, marine engineer of fireboats, marine fireman of fireboats, or hydrant-gateman; and said terms further shall mean, from the effective date of their employment in said department, persons employed on July 1, 1960, regardless of age, or employed after said date at an age not greater than the maximum age then prescribed for entrance into employment in said uniformed force, to perform the duties now performed under the title of chief operating engineer, operating engineer and junior operating engineer in the fire department, provided, however,

that any such person who on said date is a member of the system under section 165 or 165.2 of the charter shall have the option to be exercised in writing, on a form furnished by the retirement system and to be filed in the office of said system not later than ninety days after said date, of being members of the system under section 165 or 165.2 instead of section 171.1, the election under said option to be effective on said date, provided, that members who are absent by reason of service in the armed forces of the United States, or by reason of any other service included in section 161 of the charter, on said date, shall have the same option of electing to be members under section 165 or 165.2, as the case may be, instead of section 171.1, until ninety days after their return to service in the fire department. On and after said date the persons who affirmatively exercise said option, shall continue to be members of the system under section 165 or 165.2, respectively, and shall not be subject to any of the provisions of section 171.1. Any fire service performed by such member of the fire department outside the limits of the city and county and under orders of a superior officer of any such member, shall be considered as city and county service, and any disability or death incurred therein shall be covered under the provisions of the retirement system.

"Retirement system" or "system" shall mean San Francisco City and County Employees' Retirement System as created in section 158 of the charter.

"Retirement board" shall mean "retirement board" as created in section 159 of the charter.

"Charter" shall mean the charter of the City and County of San Francisco.

Words used in the masculine gender shall include the feminine and neuter genders, and singular numbers shall include the plural and the plural the singular.

"Interest" shall mean interest at the rate adopted by the retirement board.

ARGUMENT FOR PROPOSITION "J"

A "yes" vote on Proposition "J" would correct an oversight that occurred in 1949 when the engineers were not mentioned in a charter amendment that included hydrant-gatemen, marine pilots, marine engineers, and marine firemen as "members of the Department" for the purpose of the retirement system. The above group have social security rights.

The engineer responds to all fire alarms when on duty and to major fire alarms when off duty. He is subject to the same rules and regulations, the same disciplinary action, and the same hazards and risks as the above mentioned group.

This amendment has the full approval of the Fire Commission.

ARGUMENT AGAINST PROPOSITION "J"

Vote "No" on Proposition "J" Firemen's Pensions for Engineers

Voters should reject this giveaway measure allowing operating engineers in the fire department to have liberal firemen's pension benefits. These employees work in pumping stations and do not fight fires.

There are three good reasons for voting no on "J": 1) These employees are not firefighters and are not entitled to firemen's pensions which are based on job hazard. 2) This unjustified amendment would be the opening wedge for other non-firefighting employees to demand firemen's costly pension benefits. 3) Federal Social Security is available to these men—it is not available to firemen. This is true because the State of California has said that operating engineers are not firemen and cannot be excluded from social security as all firemen are.

Proposition "J" would cost the taxpayers \$56,714 a year to give this coverage to 16 employees—this is an average increase of nearly \$300.00 monthly per man!

The Civil Service Commission also opposed this measure because they

saw no valid reason why these employees should have special benefits.

Seldom has a proposal so lacking in merit as Proposition "J" been placed on the ballot. You should express your opinion of such unsound and costly measures with a resounding "No" vote.


Should proposition "J" be enacted, the increase in the cost of government of the City and County of San Francisco, based on a report prepared by the Employees' Retirement System, is estimated to be about \$56,700.00 per annum. Based on the 1959-60 assessment role, said amount of \$56,700.00 is equivalent to four tenths (0.4) of one cent in the tax annually.
