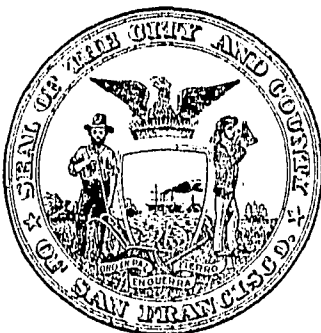

CHARTER AMENDMENT No. 1

PARK DEPARTMENT.

Describing and setting forth a proposal to the electors of the City and County of San Francisco, to amend the Charter of said City and County by amending section 40 thereof relating to the park department, by providing that certain employees of said department shall be subject to the civil service provisions of the Charter.

The Board of Supervisors of the City and County of San Francisco hereby submits to the electors of the City and County of San Francisco at the general municipal election to be held on the 5th day of November, 1935, a proposal to amend the Charter of said City and County by amending section 40 thereof so that the same shall read as follows:

PARK DEPARTMENT.

Section 40. The park department shall be under the management of a park commission consisting of five members who shall be appointed by the mayor and shall serve without compensation. The term of office of each commissioner shall be four years, provided that the commissioners in office at the time this charter shall go into effect shall be continued in office until twelve o'clock noon on the 15th day of January of the year of expiration of their terms, and thereafter their successors shall be appointed for four-year terms, commencing at twelve o'clock noon on the 15th day of January in such respective years.

The park commission may appoint a secretary, a superintendent of parks, and such assistant superintendents, directors, organizers, heads of departments, supervisors, and employees acting in a managerial capacity exclusive of foremen engaged in ordinary maintenance operations, each of which said appointees shall hold his position at the pleasure of said commission. The superintendent shall be the chief executive of the department. He shall appoint, subject to the civil service provisions of the charter, all other em-

employees of the department whose employment is subject to the civil service provisions of this charter. All said employees of said park department, except those in this section specifically exempted from the civil service provisions of this charter and who were employed in said department on the third day of September, 1935, and who shall have been so employed for twelve months in the aggregate during the two years immediately prior to said third day of September, 1935, shall be continued in their respective positions as if appointed thereto after examination and certification from a list of eligibles and shall be governed by, and shall thereafter be subject to, the civil service provisions of this charter and shall be entitled to all the benefits thereof; provided, however, should any position or employment in said park department call for the performance of duties of an extremely technical nature or when it would be extremely difficult to test the qualifications of applicants for such position or employment by an examination, then the civil service commission may, upon request from the park commission, exempt such position or employment from the civil service requirements of this section.

Whenever, because of lack of work or lack of funds, it becomes necessary to reduce the force of the employees employed in any class on the third day of September, 1935, the last employee appointed in any class shall be laid off first.

The park commission shall be successors in office of the park commissioners holding office in the city and county at the time this charter shall go into effect and shall have all the powers and duties thereof, except, ordinance-making powers and except as in this charter otherwise provided.

CHARTER AMENDMENT No. 2

HEALTH DEPARTMENT EMPLOYEES SHALL BE SUBJECT TO CIVIL SERVICE.

Describing and setting forth a proposal to the electors of the City and County of San Francisco, to amend the Charter of said City and County by amending section 142 thereof relating to inmate or institutional help, by providing that certain employees of the Department of Public Health shall be subject to the civil service provisions of the Charter.

The Board of Supervisors of the City and County of San Francisco hereby submits to the electors of the City and County of San Francisco, at the general municipal election to be held on the 5th day of November, 1935, a proposal to amend the Charter of said city and county by amending section 142 thereof so that the same shall read as follows:

POSITIONS.

Section 142. All positions in all departments and offices of the city and county, including positions created by the laws of the State of California, where the compensation is paid by the city and county shall be included in the classified civil service of the city and county and shall be filled from lists of eligibles prepared by the civil service commission, exception (1) positions in which attorneys and physicians are employed in their professional capacity to perform only duties included in their professions, but exclusive of any administrative or executive position for which such professional status constitutes only part of the qualifications therefor; and (2) inmate help or student nurses in the institutions of the city and county under control of the Department of Public Health, where the compensation including the value of any allowances in addition thereto, is less than Fifty Dollars (\$50.00) per

month, and part time services in other departments where the compensation including the value of any allowances in addition thereto is less than Eighty (\$80.00) Dollars per month, and (3) persons employed in positions outside the city and county upon construction work being performed by the city and county when such positions are exempted from said classified civil service by an order of the civil service commission; and (4) persons employed in positions in any department for expert professional temporary services, and when such positions are exempted from said classified Civil Service for a specified period of said temporary service, by order of the civil service commission; and (5) such positions as, by other provisions of this charter, are specifically exempted from, or where the appointment is designated as exclusive of, the civil service provisions of this charter.

The civil service rights, acquired by persons under the provisions of the charter superseded by this charter, shall continue under this charter.

Where existing positions that have heretofore been exempt from civil service examinations are now made subject to examination by this charter, the incumbents of such positions who have held such positions for a period of one year continuously next preceding the time that this charter shall go into effect, shall be continued in their positions as if appointed thereto after examination and certification from a list of eligibles and shall be governed thereafter by the provisions of this charter.

All incumbents of full time positions in the institutions of the city and county under the control of the Department of Public Health, as institutional help, who have held such positions for a period of six months continuously next preceding the time that this section is approved by the electors, shall be continued in their positions as if appointed thereto after examination and certification from a list of eligibles, and shall be governed thereafter by the civil service provisions of this charter.

Any person holding a salaried office under the city and county, whether by election or appointment, who shall during his term of office, hold or retain any other salaried office under the government of the United States, or of this state, or who shall hold any other salaried office connected with the government of the city and county, or who shall become a member of the legislature, shall be deemed to have thereby vacated the office held by him under the City and County.

CHARTER AMENDMENT No. 3

CALIFORNIA PALACE OF THE LEGION OF HONOR.

Describing and setting forth a proposal to the electors of the City and County of San Francisco, to amend the Charter of said City and County by amending Section 50 thereof relating to the California Palace of the Legion of Honor, by providing that certain employees of the California Palace of the Legion of Honor shall be subject to the Civil Service Provisions of the Charter.

The Board of Supervisors of the City and County of San Francisco hereby submits to the electors of the City and County of San Francisco at the general municipal election to be held on the 5th day of November, 1935, a proposal to amend the Charter of said City and County by amending Section 50 thereof so that the same shall read as follows:

CALIFORNIA PALACE OF THE LEGION OF HONOR.

Section 50. The California Palace of the Legion of Honor shall be known as such in perpetuity. The management, superintendence, and operation thereof and the lands set aside therefor, shall be vested in a board of eleven trustees, of which the mayor and the president of the park commission shall be ex-officio members. All vacancies occurring in said board shall be filled by the vote of the remaining members thereof. None of said trustees shall receive any compensation for his or her services. Trustees need not be residents of the city and county.

The Board shall have exclusive charge of the said memorial, the lands set aside therefor, and its affairs, and of all real and personal property thereunto belonging, or which may be acquired by loan, purchase, gift, devise, bequest or otherwise, when not inconsistent with the terms and conditions of the loan, gift, devise or bequest. It shall meet for its purposes at least once in three months and at such other times as the president or any three members thereof may appoint, in a place provided for the purpose. It may appoint a director, a curator, a secretary, an assistant director, museum instructors, and an organist, each of whom shall hold their respective positions at the pleasure of said board. It may also appoint, subject to the civil service provisions of the charter, such other employees and assistants as may be necessary. All incumbents in positions under the charge of said board, except the director, the assistant director, the curator, the secretary, museum instructors and the organist, who have held their respective positions for the period of one year continuously next preceding the third day of September, 1935, shall be continued in their said positions as if appointed thereto after examination and certification from a list of eligibles, and shall thereafter be governed by the civil service provisions of the charter; provided, however, should any position or employment under said board call for the performance of duties of an extremely technical nature or when it would be extremely difficult to test the qualifications of applicants for such position or employment by examination, then the civil service commission may, upon request from said board, exempt such position or employment from the civil service requirements of this section. The secretary shall keep a full account of all property, money, receipts and expenditures, and a record of all its proceedings, and shall file annually a report with the controller. The trustees shall have power to insure loan exhibits against any risk.

The supervisors, for the purpose of maintaining, operating, and superintending said memorial, and the purchase of objects of art, literary productions, and other personal property, shall provide an amount sufficient for the maintenance, operation and superintendence thereof, subject to the budget and fiscal provisions of this charter, and to that end shall levy a tax annually, the proceeds of which shall be credited to and deposited in a fund in the treasury of the city and county to be known as the "California Palace of the Legion of Honor Fund," and shall be used exclusively for the purposes thereof.

It is the intention that the administration and control of the California Palace of the Legion of Honor shall be continued with the powers granted and under the conditions imposed by the terms of the donation and accepted by the city and county.

CHARTER AMENDMENT No. 4

AIRPORT.

Describing and setting forth a proposal to the electors of the City and County of San Francisco, to amend the Charter of said City and County by amending Section 125 thereof relating to employments under the Public Utilities Commission by providing that certain employments of said commission shall be subject to the civil service provisions of the Charter.

The Board of Supervisors of the City and County of San Francisco hereby submits to the electors of the City and County of San Francisco at the general municipal election to be held on the 5th day of November, 1935, a proposal to amend the Charter of said City and County by amending Section 125 thereof so that the same shall read as follows:

EMPLOYMENTS.

Section 125. All employees engaged in public utility work at the time this charter shall go into effect, and who have been permanently appointed to their respective positions in conformity with the civil service provisions of this charter, shall become employees of the public utilities commission under the classification held by each such employee at such time. All persons employed in the operating service of any public utility hereafter acquired by the city and county, at the time the same is taken over by the city and county, and who shall have been so employed for at least one year prior to date of such acquisition, shall be continued in their respective positions and shall be deemed appointed to such positions, under, and entitled to all the benefits of, the civil service provisions of this charter; provided, however, that no person who is not a citizen of the United States shall be so continued in or appointed to his position. All persons residing outside the city and county claiming benefit of this provision and who are not engaged on such utility work outside of the limits of the city and county shall be allowed a reasonable time, not exceeding one year, to become residents of the city and county.

Persons employed as platform men or bus operators in the operating department of the municipal railway system shall be subject to the following conditions of employment: The basic hours of labor shall be eight hours, to be completed within ten consecutive hours; there shall be one day of rest in each week of seven days; all labor performed in excess of eight hours in any one day, or six days in any one week, shall be paid for at the rate of time and one-half.

The Public Utilities Commission shall have jurisdiction over the air-port now being conducted by the City and County of San Francisco as well as over any other air-port which the said city and county may acquire. All employees of the present San Francisco Airport, including the superintendent thereof, who are actually employed at said air-port on the 3rd day of September, 1935, and who have been continuously so employed for one year immediately preceding said date shall be continued in their respective positions as if appointed thereto after examination and certification from a list of eligibles and shall thereafter be governed by, and be subject to, the civil service provisions of this charter. The Manager of Utilities shall have the right to assign the Superintendent of the San Francisco Airport to perform the duties of superintendent of any other air-port under the jurisdiction of the Public Utilities Commission.

CHARTER AMENDMENT No. 5

INVESTIGATIONS OF POLICE DEPARTMENT.

Describing and setting forth a proposal to the qualified electors of the City and County of San Francisco, State of California, to amend the Charter of the City and County by adding a new section thereto to be numbered Section 35A, relating to investigations of Police Department.

The Board of Supervisors of the City and County of San Francisco hereby submits to the qualified electors of said City and County at the general municipal election to be held on the 5th day of November, 1935, a proposal to amend the Charter of the City and County by adding a new section thereto to be known as Section 35A, relating to Investigations of Police Department.

INVESTIGATIONS OF POLICE DEPARTMENT.

Section 35-A. The Board of Police Commissioners shall, of its own motion, and without the filing or presentation of any complaint, have power to initiate and conduct investigations of all matters affecting or relating to affairs of the Police Department or the discipline of the members thereof, and for the conduct of such investigations, shall have power to take and hear testimony touching the matters under investigation, administer oaths and affirmations, and upon such investigations, and upon the trial or hearing of all matters, jurisdiction to try or hear which is given by this Charter to said Board, shall have power to issue subpoenas for the attendance of witnesses and the production of books, papers and documents pertinent to the matter under investigation, or to said trial or hearing. Whenever any person subpoenaed to appear and give testimony or to produce such books, papers or documents as required by such subpoena, shall refuse to appear or testify before said Board, or to answer any questions which the majority of said Board shall decide to be proper and pertinent, he shall be deemed in contempt of said Board, and it shall be the duty of the President of said Board to report the fact to the presiding judge of the Superior Court of the City and County of San Francisco, State of California, who shall thereupon issue an attachment in the form usual in said Superior Court, directed to the Sheriff of said City and County, commanding said Sheriff to attach such person and forthwith bring him before said presiding judge of said Superior Court. On the return of said attachment, and the production of the person attached, the said presiding judge shall have jurisdiction of the matter, and the person charged may purge himself of the contempt in the same way, and the same proceedings shall be had, and the same penalties may be imposed and the same punishment inflicted as in the case of a witness subpoenaed to appear and give evidence on the trial of a civil cause before a Superior Court of the State of California. Any member of said Board or the Secretary thereof upon the order of said Board shall have power to issue any subpoena herein provided for.

CHARTER AMENDMENT No. 6

QUALIFICATIONS AND TESTS.

Describing and setting forth a proposal to the electors of the City and County of San Francisco, to amend the Charter of said City and County by amending Section 145 thereof relating to qualifications and tests, by modifying the procedure for Civil Service examinations.

The Board of Supervisors of the City and County of San Francisco hereby submits to the electors of the City and County of San Francisco at the general municipal election to be held on the 5th day of November, 1935, a proposal to amend the Charter of said City and County by amending Section 145 thereof so that the same shall read as follows:

QUALIFICATIONS AND TESTS.

Section 145. All applicants for places in the classified service shall submit to tests, which shall be competitive and without charge to the applicants. The commission shall control all examinations and may employ suitable persons in or out of the public service to act as examiners. The tests may be written, oral, mechanical or physical, or any combination of them, practical in character and related to matters fairly to test the relative capacity of applicants for the positions to be filled, and may also include credits or points for physical fitness, experience, education, seniority in service, ascertained merit, personality and fitness, and any other test which, in the judgment of the commission, will test the qualifications of the candidate for the position which he seeks; provided, however, that in all examinations, except those held for eligibles for appointment in the police department and fire department, as well as for eligibles for positions in the mechanical trades and occupations, and for positions and occupations, the duties of which are exclusively manual in character, a written test shall be given to ascertain the qualifications of those participating in such examination, and at least fifty per cent of the possible credits or points which may be obtained by any participant in such examinations shall be based upon said written tests, and provided further that not more than twenty per cent of the possible credits or points shall be based upon oral tests. The remainder of credits or points to be allowed to said participants may be apportioned as, in the judgment of the Civil Service Commission, shall be deemed proper upon physical fitness, experience, education, seniority in service, ascertained merit, and upon any other subject which, in the judgment of the Civil Service Commission, will test the qualifications of the candidate for the position which he seeks. Whenever candidates for any examination are questioned orally upon any matter testing their qualifications for the positions which they seek, the commission shall cause a stenographic record to be kept of all said questions and answers, and the commission shall, within thirty days after the result of said examination is announced, cause a transcript of said examination, or of any part thereof, to be made, upon the request of any participant in said examination, and the payment of the reasonable cost of said transcript as determined by said commission at the time of said request. The individual ratings of examiners or discussions relative thereto shall not be deemed a part of the record of any oral examination.

The commission may fix a minimum qualifying mark for any or all portions of any examination. Any candidate not attaining said qualifying mark shall not participate further in said examination and said commission shall fix a minimum passing mark for said written test as a whole, and any candidate who has not attained said minimum passing mark shall not be placed upon the eligible list to be created by said examination. The commission may also determine the total number of persons who shall constitute said eligible list. The commission shall prepare from the returns of the examiners the list of eligibles, arranged in order of relative excellence. No question submitted to applicants shall refer to political or religious opinions or fraternal affiliations.

Applicants for entrance positions in the uniformed forces of the fire and the police departments shall not be less than twenty-one years of age, nor more than thirty-five years of age at the time of appointment and shall have, at least, the physical qualifications required for enlistment in the United States Army, Navy and Marine Corps. Any examination to test the eligibility of any applicant for appointment in the police or fire departments may be based on written tests and/or upon any other subject which will, in the judgment of the commission, test the qualifications of the candidate for the position which he seeks. The commission may also allow, in such examination, credits or points for experience, and/or seniority in service, and/or ascertained merit.

Applicants for positions in the mechanical trades and occupations may, in the discretion of the commission, be rated solely on experience and physical qualifications which may be demonstrated by such evidence and in such manner as the commission may direct, and such applicants may be subjected to such further tests as the commission may require. Examinations of laborers shall relate only to physical qualifications, and laborers establishing their fitness shall rank upon the register in order of priority of application. Tests given to test the qualifications of any candidate to operate any mechanical device which may be used in connection with work incident to a position, which is subject to a written examination, shall be deemed a part of the written test of any such examination.

The commission may remove all names from the list of eligibles after they have remained thereon for more than two years and all names thereon shall be automatically removed at the expiration of four years without action by the commission. The commission may, however, provide in the scope-circular of any examination that the list of eligibles secured thereby shall automatically expire at a date not less than two or more than four years after the adoption of such list.

Veterans with thirty days or more actual service, and widows of such veterans, who become eligible for appointment by attaining the passing mark for inclusion on the list of eligibles in any entrance examination, shall be allowed an additional credit of 5 per cent in making up the list of eligibles secured by such examination. The term "veteran" as used in this section shall be taken to mean any person who has been mustered into, or served in, the Army, or enlisted in, or served in, the Navy or Marine Corps, of the United States, in time of war and received an honorable discharge or certificate of honorable active service. In the case of promotive examinations, when the passing mark for inclusion on the list of eligibles has been attained, an additional credit of 3 per cent shall be allowed to veterans or to widows of such veterans. No more than one such entrance preference, and one such promotive preference may be allowed to any one person; provided, such preference shall be deemed allowed only when the person claiming preference actually receives an appointment to a permanent position from the list which included the preference. The civil service commission may, for services or employment specified by the commission, allow general or individual preference, but not less than 10 per cent, for entrance appointment of veterans who have suffered permanent disability in line of duty, provided that such disability would not prevent the proper performance of the duties required under such service, or employment, and provided that such disability is of record in the United States Veterans' Bureau.

Charter Amendment Number 1 extends the merit system to approximately 600 positions of the park department. *It eliminates the spoils system method of filling these positions* and requires that appointments to positions be made on the basis of civil service examinations. This affords all citizens the opportunity of competing for the positions.

There is no additional cost to the taxpayer and the tendency under civil service, as proven in the past, is to make possible lower costs through increased efficiency. The merit system means honest labor returns for your tax dollar.

UNANIMOUSLY APPROVED

San Francisco has endorsed the principles of civil service as the right means of regulating public employment. This amendment extends it to a department which has heretofore been exempt.

The Board of Supervisors, after careful study, placed the amendment on the ballot by a unanimous vote.

The amendment will not interfere with park operations and will aid in the perpetuation of San Francisco's park system, one of the greatest in the country.

There is no interference with park supervision. Superintendents, assistant superintendents, and specialists requiring technical training are exempt from the provisions of the amendment, which merely makes subject to the civil service provisions of the charter employees who are used for ordinary work—gardeners, truck drivers, caretakers, etc.

NO LIFE JOBS

It does not mean that the public employee has been granted a life job. The civil service worker may be dismissed as readily as the worker in private employment. He must do his work. The merit system provides only that the public employee shall be free from political influence and that he shall not be removed so long as he does his work well. He shall be selected for merit and retained so long as he is competent.

This amendment will save the taxpayer money through improved public service and assurance of honest labor returns. Wages are not involved.

Charter Amendment Number 2 provides that employees in San Francisco hospitals known as "institutional help" in the Department of Public Health shall be subject to the civil service provisions of the charter.

In all branches of the city government there is no department which is

more vital to the welfare of the public, nor in which proper methods of employment administration are more needed, than in the Department of Public Health. Employees of San Francisco health institutions perform a service which demands that workers be selected for fitness and competence. They tend the city's sick and injured. They keep the hospitals clean, prepare and serve the food, and do the many tasks which, of necessity, must be performed by employees other than physicians, nurses, and student nurses, who are not affected by this amendment.

Wages are not involved.

The amendment will save the taxpayers money through increased labor returns and improved public service.

The Supervisors voted unanimously to place the amendment on the ballot.

MERIT WILL COUNT

Nearly 500 positions of orderlies, maids, custodians and caretakers in San Francisco health institutions are now held by appointment only. This amendment provides that such positions shall be filled through civil service examinations and that all citizens shall have the opportunity of competing for the posts.

The amendment means that positions shall not be subject to political influence and that they shall be filled on the basis of merit of the applicants.

LOWEST PAID WORKERS

These are the lowest paid workers in the employ of the city. They ask nothing more than to be free from political influence and to be judged solely on the merit of their work.

That is what Amendment No. 2 provides.

San Francisco has endorsed the merit system as the proper method of administering public employment. Amendment Number 2 extends that citizen-endorsed method to one of the most important departments of the city government.

Charter Amendment Number 3 does not cost the taxpayer of San Francisco a cent in additional expense. On the other hand, through increased and continued efficiency it will save money, and will make safe the art treasures housed in the Palace of the Legion of Honor.

Amendment Number 3 will extend the protection of the merit system to the positions at the Palace of the Legion of Honor. This does not cover positions requiring great technical skill or highly specialized knowledge, such as organists, lecturers, etc. It will cover only the gallerymen, janitors, laborers, engineers, etc.

CORRECTS MISTAKE

San Francisco has endorsed the principle of the merit system. It has put that principle into application and civil service exists throughout the city and county government. Some 20 positions at the Palace of the Legion of

Honor were "forgotten" in the present charter and it is these positions that Amendment Number 3 will cover.

ENDS SPOILS SYSTEM

The fact that the institution is one of the city's greatest cultural assets makes it all the more necessary that its operation be taken entirely from the menace of the spoils system, and placed under the merit plan where competitive examinations will select the best available man for the vacant positions.

There is no money involved in Amendment Number 3. Wage scales are not affected and there will be no increase in personnel through extension of the merit system.

Charter Amendment Number 4 provides for extension of the merit system to positions at the municipal airport. At present but 20 positions are concerned, but with future aviation development, and with a second municipal airport planned at Yerba Buena Shoals, it is probable that the positions affected will soon exceed 100.

The amendment will not cost the taxpayers a cent in additional expense. There will be no more employees needed under civil service than under the present appointive system. Wage scales are not affected by this amendment.

ASSURES BETTER SERVICE

With more than 16,000 planes arriving and departing from the municipal airport during the past year, with more than 20,000 passengers cared for without accident, it is obvious that aviation is no longer a baby industry so far as the municipality is concerned. In years to come, these figures will soar. And the men responsible for the safe handling of these planes and passengers should be the best available to the city.

Amendment Number 4, in placing the positions under civil service, throw the jobs open to all the citizens of the city, through competitive examinations. At the present time, these positions are appointive, or, in other words, are wide open to manipulation through the political spoils system.

A thing as important as aviation to the welfare of the city, and to the lives of the citizens, should not be under political domination. Amendment Number 4 will remove the menace of the spoils system from the present airport and from all others to be created.

Charter Amendment Number 6 will tend to prevent fraud in Civil Service Examinations. The charter now gives the Civil Service Commission arbitrary powers in the matter of examinations. By holding oral examinations, the Commission may, without check or record, give applicants whatever marking the Commission desires, with no opportunity for a review of the examinations.

A corrupt administration could build up a political machine under the cloak of the Merit System, by using oral examinations. Candidates thereby could be selected by politically minded examining boards, which would give political henchmen Civil Service life tenure.

MECHANICS EXEMPT

The proposed amendment requires all candidates to qualify as to their competence by passing a written test and further provides that not more than twenty per cent of the obtainable credits on an examination shall be given for any oral test. *These restrictions would not apply, however, to the mechanical trades* and to occupations manual in character or calling primarily for physical or athletical qualifications.

The amendment also provides that when oral examinations are used, a stenographic record shall be kept of the questions and answers of the oral examination, and that such record shall be open to review by the candidates. This will discourage political favoritism.

HELPS VETERANS

The amendment further clears up wording of the present charter in relation to Veterans Preference, by making it plain that a veteran shall not be considered as having used his preference unless he shall have received a permanent appointment to a permanent civil service position.

The greatest criticism against the Merit System has been aroused by oral examinations. The recent investigation of the State Civil Service System by a Senatorial Investigating Committee brought out the evils of an oral examination.

Amendment Number 6 will eliminate the oral examinations as a danger to the San Francisco Civil Service System. The citizens of this City have repeatedly indicated that they are for a political proof Merit System of Municipal employment.

Resolution No. 2359, as follows:

WHEREAS, The electors of the State of California at a general election held on November 6, 1934, adopted an amendment to Article VI of the Constitution of the State of California providing for method of selection of justices of the Supreme Court and of the District Courts of Appeal and judges of the Superior Court, which amendment is designated as Section 26 of Article VI of the Constitution of the State of California; and

WHEREAS, The Legislature of the State of California adopted an act entitled "An act to provide means for making applicable to judges of the Superior Courts the provisions of Section 26 of Article VI of the Constitution of this State relating to the method of selecting judges," which said act was approved by the Governor on July 15, 1935, and constitutes Chapter 574 of Statutes of 1935 and which said act is in full force and effect.

WHEREAS, It is provided by said constitutional section that its provisions shall not apply to the judge or judges of the Superior Court of any county until a majority of the electors of such county voting on the question of the adoption of such provisions, in a manner to be provided for by the Legislature, shall vote in favor thereof; and

WHEREAS, The said act hereinabove entitled provides for the manner of submission of such proposal and for the certification of the action of the electors thereon; now, therefore, be it

RESOLVED, by the Board of Supervisors of the City and County of San Francisco, as follows:

That the Board of Supervisors of the City and County of San Francisco hereby declares that the public interest requires the submission to the electors of the City and County of San Francisco of the proposal to adopt the provisions of Section 26 of Article VI of the Constitution of the State of California as applicable to the judges of the Superior Court of the City and County of San Francisco;

That the said proposal that the provisions of Section 26 of Article VI of the Constitution of the State of California be made applicable to the judges of the Superior Court of the City and County of San Francisco be and the same is hereby submitted to the electors of the City and County of San Francisco at the general election to be held on Tuesday, the 3rd day of November, 1936.

That the Registrar of Voters is hereby directed to take all necessary steps to submit the said proposal to the electors at the said election and to include the same on the official ballot for said election in the manner provided by said Section 26 of Article VI of the Constitution and by said act of the Legislature hereinabove entitled;

That if the said proposal is approved at said election by a majority of the votes cast thereon the Board of Supervisors shall cause a certificate signed by the Presi-

dent of said Board as chairman thereof and duly dated to be filed with the Secretary of State reciting that the said proposal to adopt the provisions of said Section 26 of Article VI of the Constitution as applicable to the judges of the Superior Court of the City and County of San Francisco was approved by a majority of the votes cast thereon at said election.

Argument in favor of Proposition No. 1

SELECTION OF JUDGES

This measure provides a method of selecting the San Francisco Superior Court Judges whereby the people, at fixed periods, determine by a direct "Yes" or "No" vote whether or not a judge is fit to continue in office for another term. *This method, adopted by constitutional amendment in 1934, is already in operation with respect to the Supreme Court and Appellate Courts.*

The proposed plan provides that if a Superior Judge desires to succeed himself the people vote upon the question, "Shall Judge (name) be elected to the office for the term expiring January (year)?" If the majority vote is "Yes" the judge continues in office for a new term of six years, which is the present term. *If the majority vote is "No" the judge's term ceases, he is rendered ineligible for appointment and his successor is selected by the Governor, but only if his selection is confirmed by the Chief Justice of the Supreme Court, the Presiding Justice of the District Court of Appeal and the Attorney-General.* At the end of each six-year term the same method of submitting the judge's fitness to the people is followed. Every selection thus made by the Governor, Chief Justice, Presiding Justice and Attorney-General is required to come before the people at the next general election for approval or disapproval by a clear-cut "Yes" or "No" vote. *Thus the people pass directly upon the issue whether or not the judge has rendered the honest, capable, intelligent and fearless service the public has a right to expect.* If the people determine that the judge has demonstrated his unfitness, they can terminate his incumbency by voting upon the direct question of fitness free and clear of such matters as his own popularity or the popularity of someone else.

(OVER)

This new method of selection would take our judges out of the ruck of periodical electioneering. Hitherto they have been compelled, willy nilly, to descend from the bench in campaign years to pursue vote getting activities that interfere with their judicial duties and are, in too many instances, beneath the dignity of the court to which they belong. Our judges are required to forego private practice and we have the right to expect from them honesty, dignity, intelligence and courage in the performance of their duties. We should make it possible for them to submit their qualifications to the voters without resorting to publicity stunts or other activities unworthy of the dignity of the high offices which they occupy.

As to the method of designating a candidate in case of a vacancy it seems to be buttressed against selfish or ignoble motives on the part of any Governor who might be tempted to trifle with one of his gravest responsibilities. The Chief Justice, the Presiding Justice of the District Court of Appeal and the Attorney-General are armed with checks and counterchecks upon the action of such a Chief Executive.

The adoption of this measure will in no way destroy or affect the right of the people to recall judges, or the power to remove a judge by legislative action or impeachment.

Among the fundamental objections to said proposal we may be permitted to enumerate the following:

1. Once approved by the voters, **no legal possibility exists to change the method of selecting our judges** by election, except by another Constitutional Amendment and state-wide vote thereon.

2. Under the appointive system, as now proposed, it would be impossible to defeat or supplant an incumbent judge, no matter how bad or untrue to his trust he may prove to be. Nothing like active opposition and rivalry will tend to insure an able, fearless and upright judiciary.

3. **The best judges now have practically no opposition;** and no judge should consider himself too good to be held once in every six years of office responsible to the people, whose servant and not their master he is.

4. Judges like other men are influenced by their environment. A judge **secured in his position for life** and surrounded by influences estranged from the affairs and problems of the common citizenship, is apt to become exclusive in his sympathies and outlook upon life, and be **accommodating and complaisant to interests** totally selfish and reckless of the interests of the community and the great mass of common people, thinking in terms of property and social preferment, to the neglect of human rights and the righting of legal and social wrongs.

5. The road of opportunity for judicial preferment and service will be restricted to those having connections with the higher ups and influential in politics, business and the profession. Lack of such connections will prove an unsurmountable obstacle to the aspirant otherwise eminently qualified by reason of ability and fitness.

6. As corporation and professional interests are chiefly litigated in the court, **corporation trained and connected lawyers**, the adepts at evasion of legal obligations through technique gained in corporation service, **are the only ones** that may succeed in securing a position on the bench under the appointive system.

7. **Whatever the shortcomings of the popularity seeking judge may be, the corporation serving judge and the complaisant judge who kowtows to might and influence is far more dangerous to the interests of the community, the rights of the public, and the welfare of the masses.**

8. This proposal is one of the mile-posts in the age-long scheming for an appointive judiciary and life-long tenure, a conspiracy against the

(OVER)

democracy instituted by the framers of the State Constitution of 1879. The many successive amendments and proposals to amend Article VI of the Constitution testify to the adroit and insinuating manner in which interests expecting to profit by such changes in the selection of judges, inch by inch gradually restrict the right of the voters to have any say in the selection of those who are to judge them, and in whose hands their lives and fortunes are confided.

9. Almost without exception the men who would control and influence appointments are **lawyers retained by the great corporations**. Their main concern is to **protect these corporations in their special privileges** and powers to exact tribute from the public. These men seldom appear in court but spend their time devising ways and means to circumvent the laws for their clients, or to have them declared unconstitutional by the very judges whom they have helped to select and place in power. Such judges will readily grant injunctions against labor organizations, and will be inclined to declare laws invalid when against their interests.

10. And now we have the plan which **provides for the appointment of judges in San Francisco by the Governor**. If this plan be permitted to operate, we may be sure that fresh and large quantities of "dirt" will be shoveled into state politics. Certainly, it is not designed to purge politics, nor to remove them from the control of special interests. **A reform more treacherous to public welfare was never devised**. Under the present system of electing judges by the people, mistakes may be made, but we have never found in this democratic country that such mistakes were corrected by substituting a small group of autocrats for popular government. When United States Senators failed to respond to the will of the people, the people made **them elective by popular vote, and not by restricting the choice to a few men**.

This plan is an open invitation to scheming, intimidation, and trading for favors, coming into free play. And in the end, one man, the **Governor, shall have the power to say who shall mete out justice**, who shall declare guilt or innocence, and who shall pronounce life or death. It is the most **outrageous concentration of power** into the hands of a few, and a **backward step in government**.
