I am the author of the resolution demanding a rehearing on the twenty percent increase in rates to the Spring Valley Water Company by the State Railroad Commissioners:

In the selection of my commissioners I will give fair consideration to Protestant, Catholic, Jew and Gentile. My wish and desire is to serve all the people.

My experience as a Supervisor, as an executive and a man who can say "no" will enable me to give a progressive, economical, sane and constructive administration.

#### MABEL DORN HIRST

#### A Woman for Our Woman's Court.

Mabel Dorn Hirst was born in Salinas, Monterey County, California, forty-eight years ago. She was educated in the schools of Salinas and San Jose, and at the age of twenty-one years was married. She raised three daughters, the eldest of whom has presented her with three granddaughters.

Since being widowed, Mabel Dorn Hirst spent several years in study and attending law school. Upon completing her course of study, she was admitted to the Bar, and for several years has been actively practicing law in the office of her father, uncle and brother in the Phelan Building in this city.

Mabel Dorn Hirst comes from a family of attorneys. Her father was formerly Superior Judge of Monterey County, and her five uncles and brother all are or were well known in their profession.

There are four Police Judges who try all kinds of cases. More than a quarter involve women, and many of them concern sex crimes. Yet the men who preside over these courts try these cases in a man's way, which is not always to the best interests of those interested. Mabel Dorn Hirst is ambitious to organize a proper woman's department of the Police Court where the morbid curiosity seeker and men hangers-on will be eliminated and the cases of women handled properly.

Several years' experience doing welfare work among the prisoners of San Quentin Prison as a member of the National Pathfinders' Association and on the Prison Committee of the California Club, has given her a wide knowledge of prisoners generally and of the various elements that center about the Police Courts. This has given her a peculiar qualification to carry out her ambitions to organize a proper "Woman's Court."

# For Police Judge LILE T. JACKS

I was born in Plumas County. While a young man I came to San Francisco; served for three and one-half years as Deputy County Clerk under H. I. Mulcrevy, and was assigned as Clerk to the late Judge J. M. Seawell; while there I studied law, working

days and attending night high school and law classes, and was admitted to practice law in November, 1908.

After being admitted to practice law I followed my profession here for years, and in the recall election of 1921 was drafted by the San Francisco Bar Association as a candidate for Police Judge, winning by a large majority.

During my incumbency I have tried over 30,000 cases and collected fines of over \$20,000 per year as against a few thousands in former years. (See Auditor Boyle's Annual Report.)

I have the endorsement of the San Francisco Bar Association, the Retail Merchants' Protective Association, many civic, fraternal and commercial organizations, including the Young Men's Republican League.

I have always tried and will continue to try to be humane and kind to those in trouble. I am against willful lawlessness, such as wanton reckless automobile driving, crimes of violence, crimes against women, and the sale of unfit foodstuffs, all of which are so vital to the welfare of the public. Yet in the other varied types of cases I have endeavored to vision the humane aspects, and I do not think I have made any grave mistakes with this class of defendants.

I am for the strict enforcement of the law against all felons who have dedicated their lives to a criminal career, and as to this class, I am against their receiving probation.

### For Police Judge SYLVESTER J. McATEE

Police Judge Sylvester J. McAtee has occupied the Police Bench for more than three years by appointment from Mayor James Rolph, Jr. He is now the oldest in service upon that Bench. His record has been one of honesty, fairness and conscientious devotion to the duties of that important office. While he has enforced the law, he has given a fair deal to every defendant, no matter how poor or friendless he may have been.

# For District Attorney NORMAN D. COOK

Upon the earnest solicitation of many friends and citizens interested in the civic and moral welfare of our city, I have consented to become a candidate for the office of District Attorney.

There is not a reader of our newspapers who is not acquainted with the deplorable conditions existing in the Hall of Justice. We have spent and are spending millions of dollars upon our schools. We have an excellent School Department, and also a very efficient Police Department; yet crime continues unabated and we hear of the influence of the divekeeper, the boss, the boodler, the narcotic ring, and the influence of those preying upon the underworld, and the like. These conditions could not exist were the District Attorney to co-operate with the Police Department. If elected, I sincerely promise to bear in mind constantly the welfare of our city. I will enforce the criminal laws fairly and impartially, yet with due consideration of the legal rights of the accused, thereby supplying the missing link in the administration of justice. I will especially seek to avoid the accusation and trial of innocent persons, and will frustrate all conspiracies and attempts to make victims of the innocent. Those guilty of vicious crimes and crimes against children, girls and women will be speedily prosecuted.

Our city is committed to Municipal ownership of all public utilities, and I am in accord therewith.

I was born in Hollister, California, in 1880; have been a resident here for twenty-five years; was admitted to the Bar in 1907; attended Hastings College of the Law, 1908-11, and have been engaged in actual practice of the law and trial of cases for the past sixteen years. I was married to Cora May Reichert in 1904, and we have one child living.

# For District Attorney CHARLES M. FICKERT

I am a graduate of Stanford University, and was admitted to practice law by the Supreme Court of the State of California, and also before the Supreme Court of the United States. For two years I was Assistant United States Attorney, and thereafter served as District Attorney of the City and County of San Francisco for ten years. During my incumbency that office was never run by any individual or class of individuals, nor have I ever been

coerced into doing that which I thought to be wrong-believing that to be coerced is to be corrupted.

Courage, efficiency and judgment are the prerequisites of a District Attorney—courage to enforce the laws fearlessly and impartially; efficiency in the administration of the many important and frequently vexing affairs of the office; judgment in the determination of when to prosecute vigorously and when to temper justice with sympathetic understanding of human frailties. I always treated first offenders, and particularly those of tender age, with leniency, endeavoring at all times to correct, if possible, their criminal tendencies instead of branding them as felons. On the other hand, I have always dealt firmly with habitual criminals so that they might not be a further menace to society.

Mary Rowland's will is a forgery, likewise the signatures of the attesting witnesses; none of said witnesses appeared in court to testify, nor was any showing made excusing their absence.

I discovered this will was illegal, discovered the heirs, received telegraphic authorization to represent them in a contest. I hired R. W. Gillogley, my friend forty-five years, to seek revocation of said illegal document; and it was not until the 21st day of May, 1921, that I knew he had compromised said action without my knowledge or presence in Department No. 10.

My system will eliminate the loss or erasure of papers, and I will photograph, at my own expense, all wills having the least taint of suspicion, thereby assuring aid to the Judge or Judges in Probate matters. In the will of Mary E. Rowland, the Court was imposed upon when it made its order admitting said purported paper to probate.

By electing me to the office of County Clerk you have protection and save expensive litigation and worry.
