**CHARTER AMENDMENT No. 1—MINIMUM WAGE,
CIVIL SERVICE EMPLOYEES—Amending Section 71 of the
Charter fixing minimum compensation of Civil Service Em-
ployees at not less than 50 cents per hour.**

RESOLUTION NO. 495

(Series of 1939)

RESOLVED, That the following proposed Charter Amendment be submitted to the electors at the Election of November 7, 1939, to-wit:

CHARTER AMENDMENT No. 1 PERSONAL SERVICE ESTIMATES

Describing and setting forth a proposal to the qualified electors of the City and County of San Francisco, State of California, to amend the Charter of said City and County, by amending Section 71 of the Charter of the City and County, relating to personal service estimates.

The Board of Supervisors of the City and County of San Francisco hereby submits to the qualified electors of said City and County at the general election to be held on the 7th day of November, 1939, a proposal to amend the Charter of the City and County, as follows:

PERSONAL SERVICE ESTIMATES

Section 71. All increases in salaries or wages of officers and employees shall be determined at the time of the preparation of the annual budget estimates and the adoption of the annual budget and appropriation ordinances, and no such increase shall be effective prior to the fiscal year for which the budget is adopted. Salary and wage rates for classes of employments subject to salary standardization, as in this charter provided, shall be fixed in the manner provided in this charter. Salary and wage rates for classes of employment not subject to salary standardization, exclusive of compensations fixed by this charter, shall be recommended by the officer, board or commission having appointive power for such employments, and fixed by the budget and the annual salary ordinance. Pending the adoption of salary standards as in this charter provided, the salary and wage rates for positions subject to such standardization shall be as recommended by the officer, board or commission having appointing power for such positions and fixed by the budget and annual salary ordinance; provided that the minimum compensation for employees subject to the Civil Service provisions of this charter shall be not less than Fifty Cents (50c) per hour nor less than One Hundred Six Dollars (\$106.00) per month; and provided further that any compensation paid as of January 1st, 1931, to an incumbent who legally held a position in the city and county service at that time, shall not be reduced so long as such incumbent legally holds such position. No compensation other than the

minimum as in this Section provided shall be increased so as to exceed the salary or wage paid for similar services of like character and for like service and working conditions in other city departments or in private employments, nor so as to exceed the rate fixed for such service or position in the proposed schedule of compensations issued by the civil service commission under date of April 9th, 1930, except as such proposed schedule or compensation is amended as provided in this charter, or extended by the civil service commission to include classification not included therein.

PROPOSITION NO. 7

CHARTER AMENDMENT No. 2—VETERANS' EXEMPTION, CIVIL SERVICE—Amending Section 145 of Charter discontinuing credits of 5 per cent on other eligible lists after veteran has secured a permanent appointment.

CHARTER AMENDMENT No. 2

QUALIFICATIONS AND TESTS FOR PLACES IN THE CLASSIFIED SERVICE—VETERANS PREFERENCE

Describing and setting forth a proposal to the qualified electors of the City and County of San Francisco, State of California, to amend the Charter of the City and County of San Francisco, by amending Section 145 thereof relating to qualifications and tests under the classified service of the City and County of San Francisco.

The Board of Supervisors of the City and County of San Francisco hereby submits to the qualified electors of the City and County at the general election to be held the 7th day of November, 1939, in the City and County of San Francisco, a proposal to amend as herein set forth the Charter by amending Section 145 thereof, relating to qualifications and tests under the classified service of the City and County of San Francisco.

QUALIFICATIONS AND TESTS

Section 145. All applicants for places in the classified service shall submit to tests, which shall be competitive and without charge to the applicants. The commission shall control all examinations and may employ suitable persons in or out of the public service to act as examiners. The tests may be written, oral, mechanical or physical, or any combination of them, practical in character and related to matters fairly to test the relative capacity of the applicants for the positions to be filled. The commission shall be the sole judge of the adequacy of the tests to rate the capacity of the applicants to perform service for the City and County. The commission may, for each examination, establish a passing mark or may determine the total number of persons who shall constitute the list of eligibles. The commission shall prepare from the returns of the examiners the list of eligibles, arranged in order of relative excellence. No question submitted to applicants shall refer to political or religious opinions or fraternal affiliations.

Applicants for entrance positions in the uniformed forces of the fire and the police departments shall be not less than twenty-one years of age, nor more than thirty-five years of age at the time of appointment and shall have the physical qualifications required for enlistment in the United States Army, Navy and Marine Corps.

Applicants for positions in the mechanical trades and occupations may, in the discretion of the commission, be rated solely on experience and physical qualifications which may be demonstrated by such evidence and in such manner as the commission may direct, and such applicants may be permitted to such further tests as the commission may require. Examinations of laborers

shall relate only to physical qualifications and experience, and laborers establishing their fitness shall rank upon the register in order of priority of application.

The commission may remove all names from the list of eligibles after they have remained thereon for more than two years and all names thereon shall be removed at the expiration of four years. The commission may, however, provide in the scope-circular of any examination that the list of eligibles secured thereby shall automatically expire at a date not less than two or more than four years after the adoption of such list.

Veterans with thirty days or more actual service, and widows of such veterans, who become eligible for appointment by attaining the passing mark in any entrance examination, shall be allowed an additional credit of 5 per cent in making up the list of eligibles secured by such examination. The term "veteran" as used in this section shall be taken to mean any person who has been mustered into, or served in, the Army, or enlisted in, or served in, the Navy or Marine Corps, of the United States, in time of war and received an honorable discharge or certificate of honorable active service. In the case of promotive examinations, when the passing mark has been attained, a credit of 3 per cent shall be allowed to veterans or to widows of such veterans when requested by such veterans or widows. When an eligible has secured a permanent appointment from a list of eligibles derived from an entrance examination in which he has been allowed additional credits of 5% as herein provided, and has served the full probationary period therein as provided in this Charter, such other additional credits of 5% that have been allowed him on lists of eligibles derived from other entrance examinations shall be automatically cancelled, and his rank on such other list or lists revised to accord with his relative standing before such additional credits were added, and he shall not be allowed such additional credits in any other entrance examinations. If he has received a permanent appointment from a list of eligibles derived from a promotive examination in which he has requested and been allowed the additional credits of 3% as herein provided, and has served the full probationary period therein as provided in this Charter, such additional credits of 3% that have been allowed him on lists of eligibles derived from other promotive examinations shall be automatically cancelled, and his rank on such other list or lists revised to accord with his relative standing before such additional credits were added, and he shall not be allowed such additional credits in any other promotive examinations. The civil service commission may, for services or employment specified by the commission, allow general or individual preference, but not less than 10 per cent, for entrance appointment of veterans who have suffered permanent disability in line of duty, provided that such disability would not prevent the proper performance of the duties required under such service, or employment, and provided that such disability is of record in the United States Veterans Bureau.

PROPOSITION NO. 8

CHARTER AMENDMENT No. 3—MUNICIPAL CONDUCTORS AND MOTORMEN—Amending Section 125 of Charter allowing Municipal Railroad conductors and motormen to act as bus operators. Assignments governed by seniority of service and fitness under test by railroad management.

CHARTER AMENDMENT No. 3

Describing and setting forth a proposal to the qualified electors of the City and County of San Francisco, State of California, to amend the Charter of said City and County by amending Section 125 thereof, relating to employees engaged in public utility work, to provide for assignment of platform men of the Municipal Railway to duty as bus operators at the salary fixed for bus operators and without loss of seniority.

The Board of Supervisors of the City and County of San Francisco hereby submits to the electors of said City and County at the general election to be held on the 7th day of November, 1939, a proposal to amend Section 125 of the Charter, relating to employees engaged in public utility work, to read as follows:

EMPLOYMENTS

Section 125. All employees engaged in public utility work at the time this charter shall go into effect, and who have been permanently appointed to their respective positions in conformity with the civil service provisions of this charter, shall become employees of the public utilities commission under the classification held by each such employee at such time. All persons employed in the operating service of any public utility hereafter acquired by the city and county at the time the same is taken over by the city and county, and who shall have been so employed for at least one year prior to the date of such acquisition, shall be continued in their respective positions and shall be deemed appointed to such positions, under, and entitled to all the benefits of, the civil service provisions of this charter; provided, however, that no person who is not a citizen of the United States shall be so continued in or appointed to his position. All persons residing outside the city and county claiming the benefit of this provision and who are not engaged on such utility work outside of the limits of the city and county shall be allowed a reasonable time, not exceeding one year, to become residents of the city and county.

Persons employed as platform men or bus operators in the operating department of the municipal railway system shall be subject to the following conditions of employment: The basic hours of labor shall be eight hours, to be completed within ten consecutive hours; there shall be one day of rest in each week of seven days; all labor performed in excess of eight hours in any one day, or six days in any one week, shall be paid for at the rate of time and one-half.

Conductors and motormen may be assigned to duty as bus operators and

while assigned to such duty they shall receive the compensation fixed for such service. Such assignment shall be governed by seniority of service, subject to a qualifying test by the railroad management as to competency and to state law as to qualifications and licensing.

Positions and employments in the municipal airport, which airport by this charter is placed under the jurisdiction of the public utilities commission, shall be continued and the employees thereof shall, subject to the approval of the commission, be appointed by and hold office at the pleasure of the manager of utilities. See Digest—Francis v. Leavy, p. 134; Archer v. Civil Service Commission, p. 136.

PROPOSITION NO. 9

CHARTER AMENDMENT No. 4—FIRE DEPARTMENT —Amending Section 36 of the Charter establishing salaries of Captains and Lieutenants of the Fire Department.

CHARTER AMENDMENT No. 4

Describing and setting forth a proposal to the qualified electors of the City and County of San Francisco, State of California, an amendment to Section 36 of the Charter relating to the Fire Department.

The Board of Supervisors of the City and County of San Francisco hereby submits to the qualified electors of the City and County at an election to be held on the 7th day of November, 1939, in the City and County of San Francisco, a proposal to amend said Charter as herein set forth by amending Section 36 thereof relating to the Fire Department.

FIRE DEPARTMENT

Section 36. The fire department shall be under the management of a fire commission, consisting of three members, who shall be appointed by the mayor and each of whom shall receive an annual compensation of twelve hundred dollars (\$1200). The term of each commissioner shall be four years, commencing at 12 o'clock noon on the 15th day of January in the years 1932, 1933 and 1934, respectively, and the mayor, after the 8th day of January, 1932, shall reorganize the commission to provide for four-year terms of three commissioners, as specified in this section.

The fire commission shall appoint a chief engineer, a secretary and a department physician who shall hold office at its pleasure.

The fire commissioners shall be successors in office of the fire commissioners holding office in the city and county at the time this charter shall go into effect, and shall have all the powers and duties thereof, except as in this charter otherwise provided. The commissioners shall have power, upon recommendation of the chief engineer, to send fire boats, apparatus and men outside of the City and County of San Francisco for fire-fighting purposes.

Positions of officers and employees of the fire department legally authorized shall continue, and incumbents therein legally appointed thereto shall continue as the officers and employees of the department under the conditions governing their respective appointments, and except as in this charter otherwise provided. The annual compensations for the several ranks in the department shall be as follows: Chief engineer, \$7,200; first assistant and second assistant chief engineers, \$4,800; battalion chiefs, \$4,200; captains, \$3,000; lieutenants, \$2,820; engineers, \$2,640; chief's operators, \$2,520; drivers, stokers, tillermen, truckmen and hosemen, for first year of service, \$2,160; for second year of service, \$2,280; and for the third year of service and thereafter, \$2,400; pilots of fire boats and marine engineers of fire boats, \$3,060; firemen of fire boats, \$2,460.

Each period of twenty-four hours shall be divided into two tours of duty.

to-wit: From 8 o'clock A. M. to 6 o'clock P. M., and from 6 o'clock P. M. to 8 o'clock A. M. The uniformed force of the fire department shall be divided into two platoons, the officers and members assigned to which shall alternate on the tours of duty at intervals of not more than one week. No officer or member shall be required to remain on duty for more than fourteen consecutive hours, except when changing from one tour of duty to the other, or in case of a conflagration requiring the services of more than one-half of the force of the department.

On the recommendation of the chief engineer, the commission may reward any member of the department for heroic or meritorious conduct, the form or amount of said award to be discretionary with the commission, but not to exceed one month's salary in any one instance.

The chief engineer, or in his absence any assistant chief engineer, or in their absence any battalion chief in charge, may, during a conflagration, cause to be cut down or otherwise removed any buildings or structures for the purpose of checking the progress of such conflagration.

A Proposal to Amend Ordinance No. 3212 (New Series) of the City and County of San Francisco, Entitled:

“REGULATING THE USE OF THE STREETS OF THE CITY AND COUNTY OF SAN FRANCISCO BY SELF-PROPELLED MOTOR VEHICLES CARRYING PASSENGERS FOR HIRE, AND PROVIDING FOR THE LICENSING OF SUCH VEHICLES AND FOR A PENALTY FOR THE VIOLATION OF THIS ORDINANCE” by Adding a New Section Thereto to be Numbered Section 21b, Providing That No Permit or License Shall be Granted for the Operation of any Jitney Bus on Any Street Within a Certain Described District, and Repealing Sections 5a and 19b of Said Ordinance No. 3212 (New Series).

We, the undersigned, registered and qualified electors of the City and County of San Francisco, and comprising with other registered and qualified voters whose names are signed to other papers of identical tenor and effect, and being the number of registered voters equal to at least five per cent of the registered and qualified voters of the entire vote cast for all candidates for the office of Mayor of the City and County of San Francisco at the last preceding general municipal election, in conformity with Sections 179, 180 and 182 of the Charter of the City and County of San Francisco, petition the Honorable Registrar of Voters of the City and County of San Francisco to submit the following ordinance to a vote of the electorate at the general election to be held November 7, 1939, as provided in Section 182 of said Charter.

Said ordinance is in the words and figures following, to-wit:

Section 1. A new section, to be known as Section 21b, is hereby added to Ordinance No. 3212 (New Series), the title of which is recited in the title to this ordinance, said section to read as follows:

Section 21b. No permit or license shall be granted under the provisions of this ordinance for the operation of any jitney bus on any of the public streets of the City and County of San Francisco within the following described area or district, to-wit:

Commencing at the intersection of the southerly line of Twenty-fourth street if projected easterly to its intersection with the shore line of the Bay of San Francisco; thence westerly along said projected southerly line of Twenty-fourth street and the southerly line of Twenty-fourth street to its intersection with the westerly line of Church street; thence northerly along the westerly line of Church street to its intersection with the southerly line of Duboce avenue; thence westerly along the southerly line of Duboce avenue to its intersection with the westerly line of Fillmore street; thence northerly along the westerly line of Fillmore street and the projection thereof to the shore line of the Bay of San Francisco; thence along the shore line of the waters of San Francisco Bay in an easterly and southerly direction to the point of commencement.

Section 2. Sections 5a and 19b of Ordinance No. 3212 (New Series) are hereby repealed.

Section 3. This ordinance shall take effect and be in force from and after its passage.

(Charter Amendment No. 1)

This proposed charter amendment provides that pending the adoption of salary standardization (as provided by charter) the minimum compensation for "employees subject to the civil service provisions of this charter, shall be not less than 50 cents per hour nor less than \$106 per month."

The institutional employees in whose behalf this amendment was introduced are now being paid "prevailing rates" as determined by rates paid in the larger hospitals located in San Francisco. The amendment by its broad terms would apply to and automatically increase the rates of office boys, laundry workers and others, some of whom are now paid at rates fixed by union agreement. The amendment would increase City payroll costs by \$137,000 per year. The amendment would write into the charter a minimum rate in conflict with the existing charter provision that rates paid in the City's service shall not exceed "prevailing rates" for like service in private employment.

The charter section dealing with salary standardization provides that pay rates, subject to standardization in the City's service, "shall be not higher than prevailing rates for like service and working conditions in private employment or in other comparable governmental organizations in this State."

This proposed amendment, taken in conjunction with the salary standardization provisions of the charter, assumes that \$106 per month is the minimum compensation paid in private employment in San Francisco. This, of course, is *not the case*. However, if such minimum rate is written into the charter, it will have a controlling influence on future attempts to standardize salaries in the City's service.

The amendment was presented on behalf of institutional workers in the City's hospitals, 570 in number as listed in the Annual Salary Ordinance. It will also apply to about 100 other employees.

(Over)

During the Supervisors' hearings on the salary standardization ordinance early this year (which ordinance was held up by referendum and, on May 19th, was voted down by the people), it was erroneously stated by the proponents that the rates provided in such ordinance for these classes of institutional employment — namely, kitchen helpers, \$75 minimum, \$90 maximum; orderlies and porters, \$90 minimum, \$115 maximum — were in accordance with the rates paid in private hospitals in the City.

On the basis of this erroneous information, the Citizens Committee Against Charter Violation, which subsequently handled the campaign that led to the defeat of the ordinance, at that time raised no objection to these particular rates.

\$106 Minimum Is Higher Than Outside Maximum Rates

However, information collected late in September of this year, from eight of the largest hospitals in the City, indicates, (1) that PRESENT rates paid by the City to institutional workers are on a par with "prevailing rates" as established by the wages paid by these outside institutions; (2) that the \$106 MINIMUM rate provided in this charter amendment is HIGHER than the highest minimum rate paid by any of these outside institutions; and (3) that the \$106 MINIMUM is higher than the MAXIMUM rates paid for these services by seven of the eight hospitals referred to above.

The amendment by its broad terms includes cook's assistants, laundry workers, and others who are now paid rates that are fixed by union agreement; office assistants or office boys, and other clerical or office employments, etc.

Initial Cost, \$137,000 Per Year

The amendment, if adopted, would increase the City's payroll cost by about \$137,000 per year.

Our organizations helped defeat the salary standardization ordinance at the special election of May 19th last. This opposition was based on the fact that the so-called "salary standardization ordinance" was such in name only. Our organizations have consistently supported the salary standardization principle as established by provisions of the charter. On this basis, we have approved another charter amendment appearing on the November 7, 1939 ballot, which provides for increases which can be justified on the basis of rates paid for similar services in other cities.

Some Hospital and Institutional Workers are now trying to support their families on \$75.00 a month. In their struggle to make both ends meet on this amount, many of them have to apply to charity.

WE PAY THESE HOSPITAL AND INSTITUTIONAL WORKERS \$75.00 A MONTH AND THEN EXPECT THEM TO WORK SIX FULL DAYS EACH WEEK AND EIGHT HOURS EACH DAY WITHIN A SPREAD OF 12 TO 13 HOURS.

They come to us now with Proposition Number 6 in which they ask so little — \$106.00 a month so that they can provide their families with the necessities of life.

HOW CAN WE REFUSE THEM? The cost of such an increase will be too small to make any impression on the tax rate. We can easily afford this small raise and it will pay us back in improved standards in our City's Institutions — better morale and increased efficiency.

The principle behind Proposition Number 6 is sound and humane. This proposal establishes a minimum wage of 50 cents an hour for employees of the City and County of San Francisco subject to civil service. Ninety-eight per cent of these employees now making less than 50 cents an hour are hospital and institutional workers.

Because of their great need and the merit of their case San Franciscans will open their hearts to this proposition when they go to the polls on November 7. Opponents of Salary Standardization at the last campaign made it plain that they were not opposed to decent pay for the Institutional Workers.

(Charter Amendment No. 2)

The war veteran groups of San Francisco request the citizens of San Francisco to approve Charter Amendment No. 2.

This amendment serves to remove the confusion in the present law which has made it operate unfairly and unjustly. It also serves to limit veterans to a definite single preference in appointment and promotion under the civil service provisions of the Charter.

When the new Charter was originally drafted the Freeholders recognized that provision should be made for war veterans' preference in civil service examinations. This was done in recognition of the fact that men and women who had served their country in time of war, should, through this preference, receive an allowance for the time given to that service. This would tend to remove the handicap resulting from taking these men and women from their ordinary operations and placing them in the war service of the nation.

However, the Charter provision which was intended to secure this preference has been so interpreted by reason of its wording as to deprive many war veterans of the benefit of its terms. For example, under the present Charter provision, if a war veteran takes an examination and gains a place on the civil service list, but subsequently is not appointed to a position in the civil service because no vacancy occurs before the list expires, then that war veteran is deprived of his civil service preference in any further examination. Obviously this result is unjust to the war veteran to whom the people of San Francisco intended to extend a benefit to assist him in obtaining a civil service position.

This amendment is proposed to cure the injustice of having a war veteran lose his preference when he has passed an examination but has not received an appointment. The amendment provides that the war veteran will be entitled to a preference in the examinations that he takes until he receives an appointment to a position. The war veteran must attain a passing grade before he receives this preferential allowance so that at all times the City of San Francisco is assured of having persons properly qualified to fill the office for which the examination is held. Once he has received an appointment under this Charter Amendment, the war veteran is no longer entitled to any preference in other examinations.

This Charter Amendment does not in any manner extend the scope or amount of preference to be granted to war veterans. The same percentage of preference as is provided in this amendment now exists in the present Charter. However, the amendment does make clear that such preference shall be used up only when the war veteran receives an appointment to an office for which he has taken an examination, whether it be by original examination or by promotive examination. The amendment makes clear that he shall only be entitled to one such preference and his right to preferences is cancelled when he receives an appointment.

This limitation to one preference clears up a question now in the Charter as to whether in taking promotive examinations the veteran is entitled to preference in more than one promotive examination that he might take. When the war veteran takes a pro-

Charter Amendment No. 3



This proposed amendment clarifies Section 125 of the Charter. It provides that assignment of Motormen and Conductors on the Municipal Railway to duty as Bus Operators shall be governed by seniority, subject to tests administered by the management of the Municipal Railway as to competency and to state law as to qualifications and licensing. While so assigned to duty as Bus Operators, these employees shall receive the compensation fixed for such service.

This is the practice usually followed in street railway operations throughout the United States, both in publicly owned and privately owned companies. Adoption of this amendment will permit flexibility of personnel and assignments. **IT WILL IMPROVE SERVICE OF THE MUNICIPAL RAILWAY.** It will permit substantial **ECONOMIES** of operation. There is **NO OPPOSITION** to this amendment. It is necessary in order to **CORRECT A DEFECT** of the existing Charter.

It is unanimously submitted by the eleven members of the Board of Supervisors.

This amendment is endorsed by the Civil Service Commission, the Public Utilities Commission, Municipal Carmen's Union, Division 518, and all civic groups and organizations.

FIRE DEPARTMENT

***Amending Section 36 of the Charter Establishing
Salaries of Captains and Lieutenants of the
Fire Department***

The intent of Proposition No. 9, Charter Amendment No. 4, is to remedy an injustice of long standing in the Fire Department, the disproportion of salary increment in so far as the ranks of captain and lieutenant are concerned. It is proposed to alter the present charter section in only one respect—the salary schedule of these two ranks; no other provisions of the charter relating to the fire department will be affected. The proposed rates, establishing a monthly salary of \$235 for lieutenants and \$250 for captains, have been submitted after conference and discussion with the Board of Fire Commissioners, as well as representatives of leading business and civic organizations. The schedules were set by these representatives as being more nearly commensurate with the duties and responsibilities of the officers involved, and more in keeping with comparable rates of cities of similar size, the proposed captains' salary, for example, being identical with that of the Los Angeles Fire Department. The enactment of Proposition No. 9, Charter Amendment No. 4, is a matter of simple justice to those directly affected.

Jitneys Create Traffic Jams in Downtown Area

Banned in Other Cities

San Francisco is one of the few remaining cities in the United States where jitneys are permitted to operate. Most cities have stopped them entirely because it was found that they added to traffic jams and served no useful purpose in handling mass transportation. Los Angeles and Oakland are close-to-home examples of cities that have eliminated jitneys entirely.

136 Jitneys Operated

In San Francisco, 136 jitneys are now in operation. For the most part, they are old 7-passenger automobiles purchased by the jitney operators second-hand and, generally speaking, not in best condition. They are not subject to any regular inspection by authorities who supervise the safety of public carriers. Their insurance coverage does not insure their passengers with adequate coverage in case of a bad accident.

No Full-Time Service

Many of the jitneys operate only during the morning and evening rush hours. No schedules are prescribed for their operation — they run as they please. The street car companies render day and night service to the public.

Crowd Our Streets

The jitneys, 136 in number, use valuable street space in the downtown districts, thereby making it more difficult for the drivers of automobiles and trucks to operate freely.

Something Must Be Done

Downtown San Francisco is now overcrowded with traffic of every description. One finds it difficult to operate a private automobile today in the downtown area because of the congestion. Jitneys operating on Market and Mission Streets add a large share to this congestion, not alone because of the number operated, but because of the fact that they stop at street intersections to take on and discharge passengers in the area between the street car safety zone and the curb, thereby holding up all other vehicular traffic. Jitneys operating over Third Street make a "U" turn at Third and Market Streets, despite the heavy traffic. Street cars and buses are economical in their usage of street space, the area per passenger carried being very small as compared to jitneys.

Other Sections Need Service

The proposed ordinance would prohibit the jitneys from operating in the congested areas. It would not, however, prohibit their operation in the outlying districts — hence the jitney operators will not be thrown out of work by the passage of this ordinance. Bear in mind, too, that the street car companies will hire more men to operate street cars and buses if the jitneys are prohibited from operating in the downtown district.

For the Good of San Francisco

We believe that the best interests of San Francisco can be served by restricting jitney operation as proposed in this ordinance. The street car companies may then increase and improve their facilities, and the operation of their cars and buses will be speeded up to the advantage of the general public.
